The University offers a wide array of liberal arts and professional programs. It offers high quality, undergraduate degree programs in more than 30 fields of study, as well as graduate degrees and certificates of advanced study. The University provides financial assistance in the form of grants and scholarships to 99% of full-time undergraduate students. Arcadia also provides academic support through the Gateway to Success program, which includes ACT101 services for PA residents who qualify, and provides personal attention and resources throughout the academic year to help them succeed.
