THE REMAINING GROUPS, WHERE MEMBERS USUALLY PARTICIPATE IN THE PROGRAM ITSELF, ARE CALLED CLASSES. CLASSES INCLUDE ARTS AND CRAFTS, BIBLICAL LITERATURE, BOOK DISCUSSION, BRIDGE, CHORAL, COLLECTOR'S CORNER, CREATIVE WRITERS, DRAWING, FINANCE, GREAT BOOKS, NEEDLEWORK, PAINTING, PHOTOGRAPHY, PLAYERS, TAI CHI, AND YOGA. ALL EDUCATIONAL GROUPS SCHEDULE ACTIVITIES FROM SEPTEMBER THROUGH MAY, OFFERING MORE THAN FOUR HUNDRED EDUCATIONAL OPPORTUNITIES PER YEAR. PROGRAMS/LECTURES TYPICALLY MEET BETWEEN THREE AND NINE TIMES PER YEAR, AND CLASSES MEET AS OFTEN AS WEEKLY. CHAIRPERSONS, SELECTED BY EACH GROUP, PLAN PROGRAMS AND OBTAIN SPEAKERS OR INSTRUCTORS, AS NEEDED. EDUCATIONAL OPPORTUNITIES ARE OPEN TO ALL CWC MEMBERS, CONSISTENT WITH THE OBJECTIVE OF WELCOMING MEMBER PARTICIPATION AND ATTENDANCE AT ALL EDUCATIONAL PROGRAMS AND STUDIES. MEMBERS ARE WELCOME TO INVITE GUESTS TO ALL PROGRAMS/LECTURES AND MANY CLASSES. THE EDUCATION COORDINATION COMMITTEE ADDS POP-UP PROGRAMS AND CLASSES THROUGHOUT THE YEAR. THESE PROGRAMS COVER TOPICS THAT ARISE DURING THE YEAR, OR ARE HANDS-ON CLASSES ON SUBJECT MATTERS NOT COVERED ELSEWHERE IN THE CWC EDUCATIONAL PROGRAM. THE SUMMER PROGRAM OFFERS A VARIETY OF ACTIVITIES FOR THE EDUCATION AND ENRICHMENT OF MEMBERS DURING JUNE AND JULY.

THE COMMUNITY IMPACT COMPONENT OF THE PHILANTHROPY COMMITTEE INCLUDES PROGRAMS FOR COMMUNITY INVOLVEMENT THAT ACTIVELY INVOLVE CWC MEMBERS. TEN OF OUR NEWER MEMBERS WERE EACH ASSIGNED AN AGENCY AND MET WITH A SPOKESPERSON(S) OF THE ORGANIZATION TO GATHER INFORMATION THAT WAS USED TO PREPARE A FIVE-MINUTE PRESENTATION ON BEHALF OF HER AGENCY. IMMEDIATELY FOLLOWING THE PRESENTATIONS, THE MEMBERS IN ATTENDANCE VOTED FOR THEIR TOP THREE AGENCIES. THOSE AGENCIES RECEIVING THE GREATEST NUMBER OF VOTES WERE AWARDED FUNDS IN PROPORTION TO THE TOTAL NUMBER OF VOTES. THE FOLLOWING AGENCIES WERE SELECTED AS OUR 2017 GIFT RECIPIENTS: SUMMER CAMP READING, OFF THE STREETS, CHILDHOOD FOOD SOLUTIONS, CINCINNATI BOYCHOIR, EAST WEST EDUCATIONAL INSTITUTE, EPISCOPAL RETIREMENT SERVICES, MAXIMUM FREEDOM, MOM'S HOPE, NEVER THE LESS, AND SERENITY RECOVERY NETWORK. ADDITIONAL CASH DONATIONS WERE MADE TO THE FOLLOWING AGENCIES AND INSTITUTIONS IN ORDER TO HELP SUPPORT THEIR PHILANTHROPIC MISSIONS: JOSEPH HOUSE, MARY MAGDALEN HOUSE, OFF THE STREETS, CHATFIELD COLLEGE, BETHANY HOUSE. THE RECIPIENT OF THE 2018 PRESIDENT'S PROJECT DONATION WAS BETHANY HOUSE. BETHANY HOUSE PROVIDES MULTI-FACETED SERVICES TO MEET THE NEEDS OF HOMELESS FAMILIES IN THE CINCINNATI AREA. IT PROVIDES TEMPORARY HOUSING AND PROFESSIONAL GUIDANCE TO ASSIST BOTH PARENTS AND CHILDREN TOWARD GAINING INDEPENDENCE, EMPLOYMENT, AND HOUSING. THE DONATION SUPPLIED EDUCATIONAL COMPUTER HARDWARE AND SOFTWARE FOR THE AGENCY'S "KID ZONE" AS WELL AS PURCHASING CLOTHING AND OTHER SUPPLIES NEEDED BY THE CHILDREN. THE COMMITTEE IS GRATEFUL TO THE MORE THAN 350 MEMBERS WHO DONATED, PROVIDING IN ADDITION TO THE MONETARY DONATIONS THIS YEAR, THERE WERE A NUMBER OF NON-MONETARY DONATIONS AS FOLLOWS: PRESIDENT'S PROJECT: BETHANY HOUSE. A SHELTER SUPPORTING WOMEN AND THEIR CHILDREN, PROVIDES FOR DAILY NEEDS AND PRACTICAL EDUCATION TO HELP TRANSITION THE RESIDENTS TO INDEPENDENT LIVING. IN MAY, ELEVEN CWC MEMBERS PROVIDED DINNER AND SHARED AN EVENING OF COMPANIONSHIP AND CHILD CARE WITH BETHANY HOUSE RESIDENTS. THE ARTS AND CRAFTS CLASS CREATED PACKAGES OF ART SUPPLIES FOR EACH CHILD, AND THE CLUB SUPPLIED BOOKS FOR BOTH THE MOTHERS AND CHILDREN, ALONG WITH KROGER GIFT CARDS FOR NECESSITIES. BLANKET PROJECT. THE BLANKET PROJECT TOOK PLACE IN BOTH SEPTEMBER AND MAY. VOLUNTEERS GATHERED, EACH BRINGING SCISSORS AND AN EAGERNESS TO SNIP FLEECE INTO LAP BLANKETS. MANY MEMBERS BROUGHT SUPPLIES HOME TO CONTINUE THE WORK. THE WOMEN CUT LENGTHS OF FLEECE AND EDGED THEM TO FINISH WITH A LOVELY PRODUCT. IN NOVEMBER, WE DISTRIBUTED 187 FLEECE BLANKETS TO SEVEN AGENCIES: EPISCOPAL RETIREMENT SERVICES, FISHER HOUSE, JOSEPH HOUSE, ONE WAY FARM, THE SALVATION ARMY, SANTA MARIA COMMUNITY SERVICES, AND THE VISITING NURSE ASSOCIATION. THESE SNUGGLY BLANKETS ADDED WARMTH TO THE LIVES OF SENIORS, VETERANS, WOMEN AND CHILDREN IN SHELTERS, AND TO OTHERS IN NEED OF RESPIRE CARE. WHEN A PERSON IS HOMELESS, A HOME-COOKED MEAL SEEMS LIKE AN IMPOSSIBLE DREAM. IN OCTOBER, CWC MEMBERS MADE THIS A REALITY FOR THE RESIDENTS OF THE CENTER FOR RESPIRE CARE. THIS RESPIRE FACILITY PROVIDES QUALITY, HOLISTIC MEDICAL CARE TO HOMELESS PEOPLE WHO NEED A SAFE PLACE TO HEAL, WHILE ASSISTING THEM IN BREAKING THE CYCLE OF HOMELESSNESS. THE CENTER IS A FOURTEEN-BED, TWENTY-FOUR-HOUR FACILITY, PROVIDING MEDICAL AND NURSING CARE TO PROMOTE EFFECTIVE HEALING TO SICK HOMELESS PEOPLE. WE PREPARED A VARIETY OF DISHES THAT WERE DELIVERED TO THE CENTER AND PROVIDED MORE THAN SIX DAYS OF MEALS. THE RESIDENTS AND STAFF ARE SO VERY APPRECIATIVE AND EXPRESS SINCERE GRATITUDE. FREESTORE FOODBANK. THE FREESTORE FOODBANK IS A LEADER IN OUR COMMUNITY, RECOGNIZING THE NEEDS OF THE UNDERSERVED. PROVIDING FOOD, A BASIC HUMAN NEED, IS THEIR PRIORITY WITH THEIR GOAL BEING TO END HUNGER AND ADDRESS ITS CAUSES. THEY PROVIDE FOOD AND SERVICES THAT CREATE STABILITY AND FURTHER SELF-RELIANCE FOR PEOPLE IN CRISIS. IN JUNE, OUR MEMBERS MET AT THEIR MAYSON DISTRIBUTION CENTER AND PACKED MORE THAN TWO HUNDRED BOXES OF FOOD FOR THOSE IN NEED. JOSEPH HOUSE. JOSEPH HOUSE STRIVES TO MEET THE NEEDS OF HOMELESS VETERANS SUFFERING FROM ADDICTION. BOTH THE RESIDENTIAL AND OUTPATIENT PROGRAMS PROVIDE SUPPORT TO MAINTAIN A LIFELONG COMMITMENT TO RECOVERY. CWC MEMBERS GATHERED IN THE CLUB'S KITCHEN TO COOK MEALS FOR THE RESIDENTS. TWENTY WOMEN PREPARED SIX DIFFERENT DISHES. MORE THAN THIRTY MEN ENJOYED THE MEALS THAT WERE DELIVERED DIRECTLY TO THE FACILITY. OFF THE STREETS. OFF THE STREETS PROVIDES COMPREHENSIVE CASE MANAGEMENT FOR WOMEN WHO ARE RECOVERING VICTIMS OF SEX TRAFFICKING AND EXPLOITATION. THE SERVICES INCLUDE HOUSING, HEALTHCARE, AND COMMUNITY INTEGRATION THROUGH JOB SKILLS TRAINING. IN NOVEMBER, MEMBERS GATHERED AT OFF THE STREETS AND PROVIDED A MEAL FOR THE RESIDENTS. WE ATE ALONGSIDE THE WOMEN, PARTICIPATING IN MEANINGFUL CONVERSATIONS WITH THEM. IT WAS A VERY ENRICHING EXPERIENCE FOR BOTH THE RESIDENTS AND CWC MEMBERS. OFF THE STREETS' RESIDENTS WERE VERY GRATEFUL FOR AN EVENING OF SUSTENANCE AND FELLOWSHIP. ONE WAY FARM. ONE WAY FARM CARES FOR CHILDREN WHO HAVE BEEN VICTIMS OF ABUSE AS WELL AS VICTIMS OF HUMAN TRAFFICKING. THEY PROVIDE A VARIETY OF SERVICES INCLUDING TEMPORARY EMERGENCY HOUSING AND LONG-TERM HOUSING AS WELL AS SERVICES THAT ADDRESS THE CHALLENGES OF SPECIAL NEEDS CHILDREN. MEMBERS GATHERED IN JANUARY AND APRIL TO PREPARE MEALS, AN AVERAGE OF EIGHTEEN MEMBERS PREPARED SIX CASSEROLES, DECORATED ONE HUNDRED SUGAR COOKIES, AND PREPARED VEGGIES AND PEANUT BUTTER. ALL OF THE FOOD WAS DELIVERED TO ONE WAY FARM IN FAIRFIELD, OHIO. PROJECT CARE. HIGHLY REQUESTED GIRL SCOUT COOKIES WERE PACKED TO PROVIDE THE TROOPS WITH A TASTE OF HOME. EACH BOX INCLUDED A HANDWRITTEN, PERSONAL LETTER SHARING NEWS AND EXPRESSING GRATITUDE FOR THEIR SERVICE. A SMALL TASK FOR US GOES A LONG WAY IN SUPPORTING THOSE WHO SACRIFICE DAILY FOR OUR COUNTRY. PROJECT HEALING WATERS. IN JUNE, CWC MEMBERS MET AT MIAMI MEADOWS TOWNSHIP PARK TO SERVE LUNCH TO SERVICE MEMBERS. PROJECT HEALING WATERS FLY FISHING USES FLY-FISHING AND ASSOCIATED ACTIVITIES SUCH AS EDUCATIONAL PROGRAMS AND OUTINGS TO ADDRESS THE PHYSICAL AND EMOTIONAL REHABILITATION OF DISABLED ACTIVE MILITARY SERVICE PERSONNEL AND DISABLED VETERANS. THE LUNCHEONS NOT ONLY PROVIDED A NICE ADDITION TO THEIR FISHING TIME, BUT THEY REPRESENTED SUPPORT AND APPRECIATION TO THOSE WHO SERVED OUR COUNTRY. THE HOUSE OF FREEDOM AND MIRACLES. THE HOUSE OF FREEDOM AND MIRACLES PROVIDES ALCOHOLIC AND ADDICTED WOMEN OF DIVERSE BACKGROUNDS A STRUCTURED AND CARING ENVIRONMENT WHERE THEY CAN ADDRESS ISSUES OF POVERTY, DRUG/ALCOHOL ADDICTION, AND PHYSICAL AND MENTAL ABUSE. THIS ORGANIZATION OFFERS A HOME ENVIRONMENT WITH ONE-ON-ONE GUIDANCE, 12-STEP PROGRAM PARTICIPATION, AND REFERRALS TO OUTSIDE AGENCIES FOR HOUSING. CWC MEMBERS MET IN MARCH TO MAKE WELCOME GIFTS FOR WOMEN ENTERING THIS SOBER LIVING HOUSE. APPROXIMATELY THIRTY PRODUCTS SUCH AS PERSONAL HYGIENE ITEMS, LAUNDRY DETERGENT, AND SOCKS WERE ASSEMBLED INTO EACH BAG GIFT SLEIGH. THE GIFT SLEIGH IS A CWC MONTHLY DONATION INITIATIVE FOCUSED ON EASY WAYS TO CONTRIBUTE TO VARIOUS CHARITABLE ORGANIZATIONS IN GREATER CINCINNATI. STARTED TWENTY-FIVE YEARS AGO AS THE "HOLIDAY SOCK AND MITTEN DRIVE," IT QUICKLY BECAME A YEAR-ROUND EFFORT. FOR 2017-2018, GIFT SLEIGH COLLECTED SCHOOL SUPPLIES IN THE FALL, HATS AND MITTENS IN DECEMBER, AND TOILETRIES, BOTH FULL- AND TRAVEL-SIZED, ALONG WITH UNUSED GREETING CARDS, ALL YEAR LONG. THESE ITEMS WERE DELIVERED TO THE FOLLOWING CHARITIES: BOND HILL ELEMENTARY SCHOOL, CARESPRING NURSING HOME, CITY GOSPEL MISSION, CRAYONS TO COMPUTERS, JOSEPH HOUSE, LADY OF THE WOODS, LITTLE BROTHERS-FRIENDS OF THE ELDERLY, LITTLE SISTERS OF THE POOR, MARY MAGDALEN HOUSE, PROJECT CARE, RONALD MCDONALD HOUSE, TENDER MERCIES, VALLEY INTERFAITH COMMUNITY RESOURCE CENTER, WALNUT HILLS KITCHEN, AND YWCA DOMESTIC VIOLENCE SHELTER. SERVICE PROJECTS: ARTS AND CRAFTS PROJECTS. THE ARTS AND CRAFTS CLASS CREATED EIGHTY-SIX PILLOWS AND THIRTY-TWO PILLOWCASES FOR THE CHILDREN BEING CARED FOR THROUGH THE FERNSIDE CENTER FOR GRIEVING CHILDREN. IN ADDITION, THE CLASS ASSEMBLED THIRTY KITS CONTAINING ART SUPPLIES AND A CRAFT FOR CHILDREN LIVING AT BETHANY HOUSE.

SCHOLARS, MENTORS, AND MEMBERS OF THE PHILANTHROPY COMMITTEE ENJOYED GETTING TO KNOW ONE ANOTHER AND THIS PROVIDED AN ADDITIONAL NETWORK OPPORTUNITY FOR THE SCHOLARS.
