A committee reviews the applications, interviews the grantees and makes recommendations for funding based on support of the mission. The Board discusses and votes on the recommendations. Grantees are awarded funds based on agreement to provide a W9, use the funding only for the purpose requested and providing an annual report on the use of funds.
