During calendar year 2017, ICA purchased an airline tickets for the president Kimpton's wife to attend a board meeting. During calendar year 2018, ICA purchased one first class plane ticket for the new president Devey for a donor cultivation trip. The ticket was not treated as taxable compensation for the president.
