The review includes interviews with faculty, staff and students. The salary is compared to colleges in the college's aspirant group and other private college presidents as reported in the national and state surveys. The external auditor also reviews the information with the Audit Committee. Compensation of the Vice Presidents (VP for Business & Finance, Provost, VP for Student Life/Enrollment, VP for Institutional Advancement, VP for Communications, VP for Marketing, and the VP for Advising) is based on individual performances and comparison of peer group salary levels for comparable positions. The President prepares the annual evaluation with input from the faculty senate and presents compensation recommendations to the board compensation committee for their approval. The compensation and comparison data is also presented to the college's external auditors for their review. The external auditor reviews the information with the board audit committee. The compensation committee meets annually in August or September and the audit committee meets annually in September or October. For this tax year, the compensation committee met on September 22, 2017, and the audit committee met on September 28, 2017.
