CPLS provided a hot lunch program for its students and faculty,
designed to offer nutritionally adequate, appealing, and affordable

84 students received hot lunch assistance during the 2017-2018 school
year. Families who qualify for tuition assistance are also qualified
for reduced lunch prices for their children based on a sliding scale.
