THE AWARD HAS BECOME ONE OF THE MOST PRESTIGIOUS HONORS AN NFL PLAYER CAN RECEIVE, ESPECIALLY SINCE THE WINNERS ARE CHOSEN BY THEIR PEERS. THE RECIPIENTS SPEND SEVERAL DAYS IN BALTIMORE FOR THIS EVENT. THEY VISIT THE BALTIMORE RAVENS COURAGE HOUSE TO MEET AND INTERACT WITH THE CHILDREN WHO RESIDE THERE.
