<p>28</p> <p>Our work begins when we select a cohort group of Latinas in seventh grade and we continue our support of them through their high school graduation. Following our Developmental Model, our annual programming for each class covers twelve important themes including Academic Inspiration and Support, College Readiness, Arts, Life skills, Personal Growth, Wellness, Team Building, Outdoor Experience, and Community Engagement. These events take place at least once a month per class with the addition of a monthly in-school program during the middle school years. We also provide thoughtful group and individual mentoring throughout the six years while guaranteeing each girl a minimum of a \$5,000 scholarship when she graduates from high school and pursues further education. Our recognition ceremony where we officially welcome 8 girls from Eastway Middle School into the program. This is a ceremony where we celebrate the initiation of these 7th graders into Circle de Luz. They will be with us for the next 6 years receiving holistic programming, mentoring and a scholarship at the end of their high school graduation. We received a grant from the Carolina Panthers of \$10K to cover expenses for programming in general for our middle schoolers. We spent in this reception alone approximately \$1,500. Our 5K run at Race to Educate. We ask the families and the girls to join in this race. We pay for their registration and provide them with shirts. Nearly 70 people registered among girls, parents, and siblings. We received a grant from the Junior League of Charlotte to cover part of these expenses. The grant was for \$3,875. The expenses for registration fees and breakfast given to the families afterward and shirts made for the girls were \$2,500. There were not a high school graduating class in this fiscal year. Circle de Luz had girls from 7th grade to 11th grade. Scholarship Update: The next class graduating from high school will be in June 2019 where we will disburse scholarship funds. We did receive back from CPCC unused scholarship funds from one of our members. It will be distributed among enrolled students for the Class of 2016. We sent one of our members for the class of 2014 a total of \$3,445.36 in scholarship funds to use at UNCC.</p> <p>(Grants \$ 51,398)</p>	28a	2,898
