MARY CAMPUS") TO THE CORPORATION ON OR BEFORE JUNE 30, 2017. THE CORPORATION'S CHARITABLE PURPOSE WILL BE ACCOMPLISHED BY THE LEASING OF ST. MARY CAMPUS FACILITIES TO EXEMPT AND NON-EXEMPT HEALTH CARE PROVIDERS, HEALTH-CARE EDUCATIONAL ENTITIES, AND HEALTH-CARE RESEARCH ENTITIES.
