1. Available to any person then currently living in a residence receiving electric power from the Cooperative or any member of the household of any such person, whether or not such person is a "member" of the Cooperative as defined by its Bylaws.
2. Scholarships will be granted to attend an accredited vocational school, technical school, college, or university, hereafter referred to as the "institution."
3. Applicant must maintain at least a 2.5 grade point average on a 4.0 scale and be considered by the registrar of the institute attended to be a student in good standing.
4. Applicant must be of good character as evidenced by at least three (3) letters, two of which must be from teachers, principals, counselors, etc., from the institution they are currently attending.
5. Applicant must demonstrate a coherent degree plan and willingness to pursue a course of higher education.
6. Economic need of the applicant will be given secondary consideration.
7. Applications must be received no later than 5:00 p.m., March 15<sup>th</sup> for the fall semester. Awards will be announced by May 1st.
8. The first half of the scholarship will be made payable to the student and/or the institution upon verification of enrollment. Upon completion of the first semester, a statement will be required from the institution certifying that the applicant is considered by the registrar to be a regular student in good standing with a grade point level of at least 2.5 on a scale of 4.0. Upon receipt of this statement and proof of enrollment for the second semester, the additional one-half (1/2) of the scholarship will be issued.

This is a one (1) year scholarship. ***Persons who wish to receive a future scholarship must re-apply each year.*** Scholarships will be awarded on the criteria set forth above.
