The Library offers a monthly program event for families, including current family movies that are preceded by free pizza and drinks

The childrens' reading program during the summer includes weekly reading groups for all ages of students and covers more reading material than is required by the local schools for their summer reading lists.

During the year special programming events are offered at no cost. These events include lectures on travel, authors on recent publications and many children programs.
