As of June 30, 2018, the Facebook page had more than 12,000 followers. Donate Life uses Facebook to reach constituents and others who have an interest in organ, eye and tissue donation.

DMV Outreach - Focuses on educating Division of Motor Vehicles Examiners and State-level leaders about the important partnership between the NC Donor Registry and Donate Life NC. There are 600 DMV Examiners and we trained about 200 new ones this past year. We have 60-75 volunteer DMV Ambassadors who have visited those offices quarterly, updating materials and sharing data on office donor designation rates. By the end of June 2018, more than 5.1 million North Carolina donors were registered through the DMV.
