Approximately 65,000 visitors experienced the collection in the fiscal year 2018, including 7,360 students. The curatorial staff researches and publishes the collection, while the education staff use the collection to inspire audiences.

An estimate for the total value of objects acquired by gift in years prior to 1997 is not readily determinable. The total value of gifts received since 1997 is \$14,778,745. The total value of objects purchased from December 31, 1997, through June 30, 2018, and June 30, 2017, was \$28,652,860 and \$25,233,583, respectively. For the year ended June 30, 2017, the Museum did not make any sales of deaccessioned collections or objects of art. For the year ended June 30, 2018, the Museum made sales of deaccessioned collections with a value of \$370,715.
