NEW SCHOOL DEVELOPMENTInternationals continued to develop new schools and academies across the country due to continuing demand for innovative programs to support growing ELL populations. Internationals provided targeted professional development and leadership development supports to leaders, teachers, and other staff. Additionally, new school and academy staff were provided access to instructional resources as well as national network events such as professional development institutes, intervisitations, and the national leadership retreat. Schools and academies in New York, Virginia, Washington, DC, Maryland, and Minnesota which are in the initial 1-4 years of development received ongoing support from Internationals. Internationals continued to explore collaborations with school districts across the U.S. regarding school or academy openings in future years.

Form 990, Part III, Line 4b:

PROFESSIONAL AND LEADERSHIP DEVELOPMENT Internationals continued to offer a variety of professional development and leadership development supports to its national network schools and academies with an increasing focus on three regional hubs in NYC, CA, and DC/MD/VA. These activities included direct supports for schools and academies as well as facilitated network-wide activities. Targeted activities were designed to meet the needs of educators implementing the Internationals Approach to ELL education. Professional development staff created new workshops while continuing to further refine a core set of workshops for school leaders, teachers, and other staff. For its NYC regional network, Internationals provided multifaceted supports including, regular principal and assistant principal meetings, coaching for school leaders, support for college advisors, social workers, and counselors, as well as other forms of customized instructional and leadership support. We facilitated intervisitations among NYC network schools and supported cross-network collaboration through network-wide committees. Internationals also designed, organized, and facilitated workshops for educators from network and non-network schools at the annual Summer Professional Development Institute as well as for over 500 faculty and staff at the Annual Fall PD Conference in November in NYC. Internationals expanded regional network support for schools and academies in the DC, MD, VA region to include professional development, coaching, and other supports. Internationals also provided professional and leadership development support for its two schools in California while also serving others in Minnesota, Kentucky, and New York State. The annual National Leadership Retreat brought together school and academy staff from across the country. Internationals created new content for its online curriculum library and continued efforts to track qualitative and quantitative data on network schools and academies to inform the services and supports.

Form 990, Part III, Line 4c:

MODEL DISSEMINATIONIn addition to supporting its network schools and academies, Internationals partnered with schools and districts outside its network. Internationals provided professional development workshops to schools and districts, facilitated intervisitations across network and non-network schools, provided on-site leadership and instructional coaching in non-network schools. Educators from non-network schools participated in our professional development conferences including the summer institute and Fall PD conference in NYC. Some of this model dissemination work may eventually lead to the creation of new schools or academies. In the final year of Project RISE, Internationals continued to work with schools in the San Francisco Unified School District and the NYC Department of Education under a US DOE i3 (Investing in Innovation) grant.
