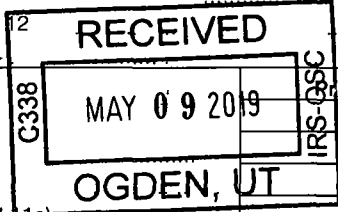

Classes are offered at all levels from beginner to advanced, for all ages from preschoolers through adults, and in a variety of traditional media- drawing, painting, ceramics, printmaking, and sculpture- to modern media. The Art School also offers Professional Development Workshops for teachers with credit available through Framingham State University.
