FOCUSING ON THE REDUCTION OF TOXIC CHEMICALS RELEASED INTO THE
ENVIRONMENT. ELM WAS A STRONG ADVOCATE IN THE LATE 1980S FOR THE
MASSACHUSETTS TOXIC USE REDUCTION ACT (THE FIRST SUCH ACT PASSED IN THE
COUNTRY), AND ELM WAS THEN INSTRUMENTAL IN ADVOCATING FOR SUFFICIENT
FUNDS TO ENABLE ITS IMPLEMENTATION. MORE RECENTLY, ELM HAS TACKLED
RIVER PROTECTION, SMART GROWTH DEVELOPMENT AND CLIMATE CHANGE. TODAY,

THE BREADTH OF ELM'S ENVIRONMENTAL ADVOCACY AND EDUCATIONAL WORK ON BEACON HILL IS COMPREHENSIVE, ENCOMPASSING SUCH CRITICAL AREAS AS LAND CONSERVATION AND MANAGEMENT AND THE PROTECTION OF WATER RESOURCES AND PUBLIC HEALTH. TO FURTHER STRENGTHEN THAT ADVOCACY EFFORT AND BRING ADDITIONAL VOICES TO THE TABLE, ELM HAS DEVELOPED A NUMBER OF STRATEGIC PARTNERSHIPS ALONG WITH PLANS FOR DEVELOPING NEW TOOLS AND COMMUNICATIONS STRATEGIES. STARTING WITH A DOZEN GROUPS THAT WANTED TO WORK TOGETHER TO ADVANCE ENVIRONMENTAL PROTECTION, THE COLLABORATIVE HAS GROWN TO 50 ORGANIZATIONS - THE LARGEST COLLECTION OF ENVIRONMENTAL ORGANIZATIONS IN THE COMMONWEALTH. THE COLLABORATIVE ALLOWS ELM TO SERVE THE LARGER ENVIRONMENTAL COMMUNITY, INCLUDING GROUPS WITHOUT A PRESENCE ON BEACON HILL.
