The GIC receives several large grants, from the Rhode Island Foundation, the Pisces Foundation, and the van Beuren Foundation to support the work of the partners and to undertake specific projects. GIC members have restored an amphibian breeding pond, disconnected downspouts on homes, depaved driveways, planted trees along watercourses and installed tree filters along streets, convened trainings for maintenance personnel on how to maintain Green Infrastructure, partnered with the RI Dept of Transportation as it attempts to meet the requirements of their consent decree with the USEPA, and works with the RI Dept of Environmental Management as it updates its stormwater and wetland regulations.

The ECRI Ed fund is the fiscal agent for the coalition and in addition to managing funds, provides all back office services.

Energize received a grant of \$50000 from the John Merck Fund and received one donation of \$9.41 (after paypal took its fees). Energize paid a consultant \$29280 to run the coalition and conduct much of the education. The Energize coalition has 6 member organizations that received allocations to support staff time for Energize work. People's Power and Light \$10000 Filarski Architecture \$5000 Citizens Climate lobby \$2500 Clean Water Fund \$2500 Conservation Law Foundation \$2500 Acadia Center \$1600 Energize transferred \$2500 to the ECRI ED Fund general account for fiscal agency services.
