Schedule R, Part III, Line 1	NEFWC is a part owner of Borinquen Apartment Manager Corporation, the general partner for Borinquen Apartments Limited Partnership, a Low Income Housing Tax Credit Development (LIHTC) with Flores Development LLC which includes a member of NEFWC's Board of Directors. In addition, NEFWC is a special limited partner in the Limited Partnership. NEFWC will serve as the administrative general partner for the Partnership. The federal government, through the American Recovery Reinvestment Act (ARRA), will serve as the investor through TC-X funds issued to the development. The Federal funding requires expertise in administering federal funds by a general partner in the development. NEFWC has not made any capital contributions to the partnership, any costs incurred by NEFWC which were minimal, were reimbursed at the LIHTC closing. NEFWC will receive a \$370,529 developer fee and 100% equity ownership in 41 apartments which received \$6,558,694 in renovations. This is Phase I. NEFWC received the remaining 16 residential apartment units from the preceding paragraph two residential apartment buildings located at 2718 Main Street and 17 East Hooker Street, Springfield MA, from Flores Development LLC which includes a member of the Board of Directors. The total cost was equal to the cost basis of the property, necessary for submission in Phase II of the LIHTC development identified in the preceding paragraph. The total cost of the buildings was \$651,505, a bank mortgage was secured for \$500,000 and a note payable to the seller for \$151,505 at 0% interest due upon successful LIHTC award and closing. This note is unsecured. At the LIHTC closing the \$500,000 mortgage and the \$151,505 note will be reimbursed by LIHTC proceeds. Additionally any costs incurred by NEFWC, which will be minimal, will be reimbursed by LIHTC proceeds. During fiscal year 2016 the closing was completed and the associated debts were paid off.
