THE AGENCY ALSO PROVIDES COMMUNITY EDUCATION AND OUTREACH ON DOMESTIC VIOLENCE AND HUMAN TRAFFICKING. OUR TRAINING PROGRAM PROVIDES TRAININGS TO COURTS, POLICE, GOVERNMENT AGENCIES, FAITH-BASED INSTITUTIONS, COMMUNITY GROUPS, AND MSP STAFF. DURING THE FISCAL YEAR, MSP PROVIDED 29 TRAININGS TO THE OUTSIDE COMMUNITY REACHING 496 PARTICIPANTS, AND 26 TRAININGS FOR MSP STAFF. OUR OPERATION SAFETY PROGRAM PROVIDES TRAININGS ON HOW TO SCREEN FOR INTIMATE PARTNER ABUSE IN HOSPITALS, CLINICS AND OTHER HEALTH CARE SETTINGS AND HOW TO MAKE APPROPRIATE REFERRALS FOR POTENTIAL VICTIMS THROUGHOUT THE COUNTY. DURING THE YEAR, MSP PROVIDED 95 TRAININGS TO 1,061 PARTICIPANTS. MSP'S DOMESTIC VIOLENCE EDUCATION & PREVENTION PROGRAM ADDRESSES THE PROBLEM OF VIOLENCE IN FAMILIES AND TEEN DATING RELATIONSHIPS BY OFFERING CHILDREN EDUCATIONAL, INDIVIDUAL AND GROUP SUPPORT SERVICES, PROVIDING 338 CLASSROOM PRESENTATIONS TO MIDDLE AND HIGH SCHOOL STUDENTS IN THE COUNTY EACH YEAR. THE SISTER IN LAW PROGRAM TRAINS VOLUNTEERS TO ACCOMPANY VICTIMS TO OUTSIDE APPOINTMENTS, INCLUDING COURT APPEARANCES, SOCIAL SERVICES APPOINTMENTS, AS WELL AS TO FILE POLICE REPORTS.
