Form 990, Part III	FORM 990, PART 111, LINE 4A - KCE's primary program is to distribute medical software and to train doctors and medical professionals in their use in clinical practice KCE is a 501(c)(3) public charity dedicated to transforming pediatric care in underserved communities by enabling doctors and medical professionals to care for sick children more effectively and at lower cost. Further information can be found at our website at www.kidscareeverywhere.org. We do this by donating software called DynaMed Plus and training doctors and medical professionals in its use. This software supercedes PEMSft, which is now incorporated into the newer software called DynaMed Plus. This software is available primarily as a mobile application, resident on a smartphone. It is often installed on hospital servers, so that it is available to all hospital personnel, for daily use. Web-based versions for laptops and desktop computers are also available, but used less frequently. DynaMed Plus is gifted to KCE by EBSCO Health, Ipswich, Ma. During the fiscal year 2017 - 2018, KCE visited and trained doctors and medical professionals in two locations in Vietnam, and four locations in Peru. In Vietnam, the KCE volunteer team conducted training and distributed DynaMed Plus to two major hospitals. In Hanoi, the National Hospital of Pediatrics, and in HCMC, City Children's Hospital. The KCE team consisted of two board members, program director and two volunteers. This team trained 230 doctors and medical professionals in the two hospitals in 8 training sessions. This was our first training trip to Vietnam introducing our newer software called DynaMed Plus. KCE also visited 4 hospitals in Peru, and in total, trained 113 doctors during 5 training sessions. The major hospital, Hospital Nacional Dos De Mayo, in Lima, Peru, was visited by a board member and Program Director. KCE reviewed PEMSft software and its new mobile features with current and new users of the software. At the time of this visit, DynaMed Plus was not yet available for hospital training and distribution. The team also introduced the mobile app and web versions of the PEMSft software to new physicians at three new hospitals in Ica, Peru. They are Hospital Santa Maria Del Socorro, Hospital IV Augusto Hernandez, and Hospital Regional De Ica.
