FIRST LEGO League - Over 550 teams participated in FIRST LEGO League tournaments in Illinois. After 37 qualifying tournaments there were three state championship events. Approximately 4000 students were involved in the program.

FIRST Tech Challenge - Over 160 teams participated in Illinois during this past year. The season included leagues, meets and qualifying tournaments and an Illinois state wide championship. Approximately 1500 students were involved in the program.

4c (Code:) (Expenses \$ 71,709 including grants of \$ 70,141) (Revenue \$ 91,624)

FIRST Robotics Competition. The FIRST Robotics Competition activity in Illinois is run by FIRST (501c3 in New Hampshire). Inscite Illinois (DBA FIRST Illinois Robotics) assists FIRST in this program. The majority of the revenue within Inscite Illinois related to FIRST Robotics Competition was local fund raising and expense payments to FIRST to cover a portion of running the Midwest and Central Regional FIRST Robotics Competitions in Chicago and Peoria respectively. Approximately 1500 students were involved on teams in Illinois.
