DOMINICAN REPUBLIC - COMMUNITIES OF THE DOMINICAN REPUBLIC ARE FACING MANY CHALLENGES AS A RESULT OF EXTREME POVERTY AND LACK OF CLEAN WATER ACCESS. MANY INDIVIDUALS ARE FORCED TO SPEND LIMITED RESOURCES ON PACKAGED WATER, WHILE OTHERS RESORT TO DRINKING WATER THAT PUTS THEM AT RISK OF CONTRACTING SERIOUS ILLNESSES. IN THIS PARTICULAR REGION OF THE WORLD, WINE TO WATER IS USING LOCAL RESOURCES TO CREATE CERAMIC WATER FILTERS, WHICH KILL 99.9% OF CONTAMINANTS. THROUGH OUR OWN DOMINICAN REPUBLIC FACTORY WE HAVE DISTRIBUTED OVER 1,600 CERAMIC FILTERS TO FAMILIES AND INDIVIDUALS THIS PAST YEAR, IMPACTING OVER 16,000 PEOPLE. THROUGH INNOVATIVE TECHNOLOGY, EDUCATION PROGRAMS, AND OUR PHENOMENAL GROUND TEAM, WINE TO WATER IS CHANGING THE WATER LANDSCAPE ALONGSIDE COMMUNITIES IN THE DOMINICAN REPUBLIC.

NEPAL - THIS YEAR, WE TOOK THE MOMENTUM OF OUR IMPACT IN DAHAKHANI TO THE COMMUNITY OF RAITOLE. ALTHOUGH THE AREA WAS HOME TO A FEW WELLS, THERE WAS NO SANITARY WATER SYSTEM TO SUSTAIN THE WHOLE POPULATION. LAST YEAR, 6 WELLS WERE REPAIRED OR NEWLY CONSTRUCTED AND MORE THAN 100 FILTERS WERE DISTRIBUTED, IMPACTING OVER 2,400 LIVES TOTAL. RAITOLE HAS SET A NEW STANDARD FOR WINE TO WATER PROGRAMS MOVING FORWARD. IT HAS TRULY REVOLUTIONIZED OUR PROJECT APPROACH INTO A COMPLEX, LONG-LASTING SUSTAINABLE PROGRAM. THE RELATIONSHIPS WE'VE BUILT ARE DEEPER THAN ANY WATER SYSTEM AND WE'RE CONTINUING TO PROVIDE SUPPORT AND FOSTER GROWTH IN THE PEOPLE OF NEPAL SO THAT THEY WILL PROSPER LONG AFTER WATER IS PROVIDED.

COLOMBIA - DESPITE HAVING THE LARGEST TRIBUTARY IN THE WORLD, THE MAJORITY OF WATER SOURCES IN COLOMBIA ARE CONTAMINATED AND OVER-CONSUMED BY VARIOUS FACTORS, SUCH AS MINING EXPLOITATION AND DRUG PRODUCTION. IN ADDITION, REGIONS LIKE LA GUAJIRA, HUILA AND TOLIMA EXPERIENCE DRY SEASONS THAT CAUSE RESIDENTS TO GO WITHOUT WATER FOR UP TO FIVE MONTHS. THIS PAST YEAR, WINE TO WATER COMPLETED 20 WELL REPAIRS OR CONSTRUCTION PROJECTS AND DISTRIBUTED MORE THAN 350 FILTERS TO COMMUNITIES LIKE TORIBIO CAUCA, WHERE THE ENTIRE POPULATION RECEIVED ACCESS TO CLEAN WATER.
