OF HEALTH INSURANCE GRANT. THE CURRENT LEGISLATION ONLY COVERED THOSE WITH GENETIC HEMOPHILIA. IN RECENT YEARS, THERE HAVE BEEN A RISE IN OTHER DIAGNOSES AND ACQUIRED BLEEDING DISORDERS. THIS BILL WILL ALLOW US THE OPPORTUNITY TO SERVICE A BROADER SPAN OF INDIVIDUALS WHO NEED INSURANCE ASSISTANCE.

THIS BILL CAME TO BE BECAUSE 70% OF PLANS ARE SELF-INSURED. THESE SELF-INSURED PLANS DO NOT NEED TO MEET STATE REQUIREMENTS, THEREFORE TRUMPING OUR NJ STANDARDS OF CARE LAW. FINALLY, THERE'S A BILL THAT PASSED WITH THE GOVERNOR'S SIGNATURE MARKING MARCH OF EVERY YEAR BLEEDING DISORDERS MONTH.
