JESPY HOUSE CELEBRATED ITS 40TH ANNIVERSARY THIS YEAR. MOST OF OUR CLIENTS HAVE BEEN PART OF THE JESPY "FAMILY" FOR 15 YEARS OR MORE, SOME FOR OVER 30 YEARS! WE ARE PROUD TO SERVE 250 CLIENTS WHO RANGE IN AGE FROM 18 TO 70. THIS HAS BEEN A YEAR OF CONTINUED GROWTH, MOST NOTABLY WITH THE CONTINUED EXPANSION OF OUR AGING IN PLACE INITIATIVE. THIS INITIATIVE WAS ESTABLISHED WITH GRANT FUNDING TO PROVIDE OUR OLDER CLIENTS AGE 45+ WITH DISTINCT PROGRAMS AND SERVICES TO SUPPORT THEIR CHANGING NEEDS AND ENSURE THAT THEY COULD REMAIN IN SOUTH ORANGE AS PART OF THE JESPY COMMUNITY FOR AS LONG AS POSSIBLE. 40% OF OUR CLIENTS ARE AGE 45-70, AND 2/3 HAVE BEEN AT JESPY FOR 15+ YEARS AS AN UMBRELLA PROGRAM. OUR AGING IN PLACE INITIATIVE ENCOMPASSES A VARIETY OF HEALTH AND WELLNESS PROGRAMS AND SERVICES TO HELP ADULTS WITH I/DD TO REMAIN IN THE COMMUNITY AS THEY AGE. ADULTS WITH I/DD MAY EXPERIENCE DISEASES AND HEALTH CONDITIONS IN THEIR 40'S THAT ARE MORE TYPICALLY FOUND IN OLDER ADULTS IN THE GENERAL POPULATION SUCH AS OSTEOPOROSIS, ARTHRITIS, AND DIABETES. THEY ARE ALSO MORE PRONE TO MENTAL HEALTH ISSUES AS THEY AGE, WITH ABOUT 30% CONSIDERED TO HAVE A DUAL DIAGNOSIS". JESPY IS THE FIRST AGENCY IN THE AREA TO IMPLEMENT A COORDINATED SERIES OF WORKSHOPS, PROGRAMS, EVALUATIONS, ASSESSMENTS, AND SERVICES TO BENEFIT THE OLDER I/DD POPULATION. ANOTHER IMPORTANT ADDITION TO OUR AGING IN PLACE INITIATIVE THIS YEAR WAS THE PURCHASE OF AN ADDITIONAL SHARED HOUSE EXCLUSIVELY FOR OUR OLDER CLIENTS. THIS PURCHASE WAS MADE POSSIBLE WITH A MAJOR GIFT. THE HOUSE IS BEING RENOVATED TO ACCOMMODATE THE NEEDS OF 9 OLDER ADULTS, SOME OF WHOM HAVE MOBILITY CHALLENGES. THE HOUSE WILL BE COMPLETELY ACCESSIBLE AND AFFORD EACH CLIENT THE OPPORTUNITY TO HAVE THEIR OWN PRIVATE SPACE AS WELL AS COMMUNAL AREAS FOR SOCIALIZATION AND PROGRAMMING NEW CONCEPTS IN THE DELIVERY OF CLINICAL AND BEHAVIORAL HEALTH SUPPORT SERVICES. WE INITIATED IMPACTING ALL CLIENT SERVICES, INCLUDING THE DAY HABILITATION PROGRAM. AS A RESULT, EACH CLIENT IN THE DAY HABILITATION PROGRAM PARTICIPATES IN A FORMALIZED ANNUAL CASE EVALUATION (ACE) WHERE THE CLIENT, FAMILY, AND STAFF IDENTIFY THE CLIENT'S ACHIEVEMENTS AND DEVELOP TARGETED GOALS FOR THE COMING YEAR. ALSO, CLIENTS BENEFIT FROM MEN'S AND WOMEN'S GROUPS WHERE RELEVANT SOCIAL AND INTER-PERSONAL TOPICS ARE ADDRESSED AND DISCUSSED. COLLABORATIONS WITH LOCAL UNIVERSITIES WERE EXPANDED AND INCLUDED SOCIAL WORK INTERNS AT BOTH THE BACHELOR'S AND MASTER'S LEVELS, WHICH BENEFITTED THE CLIENTS, THE STAFF, AND THE COLLEGE STUDENTS. THE COMMUNITY-BASED SUPPORTS STAFF COORDINATES WITH OUR CLINICAL STAFF TO OFFER CLIENTS A VARIETY OF SERVICES INCLUDING SHORT-TERM OR LONG-TERM COUNSELING, CRISIS INTERVENTION, BEHAVIORAL INTERVENTION, FAMILY COUNSELING, AND MONITORING OF MEDICATION. GROUP WORKSHOPS ARE HELD TO ASSESS, ENGAGE, AND SUPPORT CLIENTS IN IMPORTANT AREAS INCLUDING SOCIAL CONNECTIONS, COMMUNICATION SKILLS, SELF-ESTEEM, AND ANGER MANAGEMENT/CONFLICT RESOLUTION. ADULTS WITH I/DD ARE MORE VULNERABLE TO AGE-RELATED DISEASES AT A YOUNGER AGE (IN THEIR 40'S) COMPARED WITH THE GENERAL POPULATION. OUR CLINICAL TEAM IS CONDUCTING AN ACCURATE AND COMPREHENSIVE ASSESSMENT OF OUR CLIENTS TO DETERMINE THE NATURE AND COURSE OF HELPING INTERVENTIONS AND ACHIEVING GOALS THAT IMPROVE THE QUALITY OF LIFE FOR OLDER CLIENTS. USING PROVEN ASSESSMENT TOOLS, THEY WILL BE ABLE TO DIFFERENTIATE BETWEEN TYPICAL AGING AND ATYPICAL AGING AND WILL ASSESS ANXIETY, DEPRESSION, AND OTHER CLINICAL AREAS. THESE TOOLS ALLOW US TO ESTABLISH BASELINES FOR EACH OLDER CLIENT SO WE CAN TRACK AND ASSESS THEIR INDIVIDUAL CHANGES AND PROVIDE THEM WITH APPROPRIATE TREATMENT PLANS. THE TRANSITION SERVICES PROGRAM IS TAILORED TO MEET THE UNIQUE ABILITIES OF EACH CLIENT. WE EMPOWER YOUNG ADULTS WITH I/DD TO GRADUALLY AND CONFIDENTLY MOVE AWAY FROM THEIR CHILDHOOD SERVICES. THEY BEGIN TO LOOK TOWARDS THE FUTURE AS THEY TRY NEW ACTIVITIES, MAKE NEW FRIENDS, TRAIN FOR A JOB OUT IN THE COMMUNITY, AND PREPARE FOR LIVING AS A MORE INDEPENDENT ADULT. PROGRAMMING OPTIONS ARE FLEXIBLE AND ARE TAILORED TO MEET THE INDIVIDUAL CLIENT'S NEEDS AND INTERESTS. EACH CLIENT IS ASSIGNED A TRANSITIONS TEAM MENTOR WHO WORKS WITH THE CLIENT ON-ON-ONE TO IDENTIFY, SET, AND TRACK INDIVIDUALIZED GOALS. OUR TRANSITIONS CLIENTS MEET IN THEIR OWN MODEL APARTMENT WHERE THEY CAN COMFORTABLY SOCIALIZE WITH PEERS WHILE WORKING ON ADVANCING THEIR PRACTICAL EXPERIENCE FOR LIVING INDEPENDENTLY IN A RESIDENTIAL SPACE. PROGRAM GOALS AND DAILY ACTIVITIES FOCUS ON HEALTH AND SAFETY, ASPECTS OF DAILY LIVING, EMPLOYMENT SKILLS, SOCIAL/INTERPERSONAL SKILLS, AND COMMUNITY INTEGRATION. JESPY'S ATHLETICS AND FITNESS PROGRAM EMPHASIZES OVERALL PHYSICAL FITNESS, HEALTH AND WELLNESS, AND DEVELOPMENT OF SOCIAL SKILLS. JESPY CLIENTS OF ALL LEVELS OF ABILITIES ENJOY THE TEAM SPIRIT, SPORTSMANSHIP, AND OPPORTUNITY TO ENGAGE WITH OTHER ATHLETES ACROSS NEW JERSEY AND BEYOND. APPROXIMATELY 80 MEN AND WOMEN PARTICIPATE ON THE FOLLOWING TEAMS: BASKETBALL, BOCCIE, BOWLING, CHEERLEADING, GOLF, SOCCER, SOFTBALL, TENNIS, TRACK AND FIELD, AND VOLLEYBALL. TEAM SPORTS EVOLVE EACH YEAR AS THE CLIENTS' INTERESTS CHANGE. FOR MORE THAN 20 YEARS, JESPY HOUSE HAS BEEN PROUD TO BE A PARTICIPANT IN THE SPECIAL OLYMPICS NEW JERSEY GAMES. WE REPRESENT THE LARGEST GROUP OF ATHLETES IN ESSEX COUNTY AND CONTINUE TO BE SUCCESSFUL IN MANY EVENTS, WITH A LONG HISTORY OF EXCELLENCE IN ATHLETICS. IN 2017, JESPY CLIENTS WERE CHOSEN TO CARRY THE TORCH AND LEAD THE ATHLETES IN RECITING THE SPECIAL OLYMPICS OATH AT THE ESSEX COUNTY OPENING CEREMONY. FIVE JESPY ATHLETES WERE CHOSEN TO PARTICIPATE IN THE 2018 NATIONAL SPECIAL OLYMPICS GAMES IN SEATTLE, WASHINGTON. ONE CLIENT WILL BE COMPETING IN THE 2019 SPECIAL OLYMPIC WORLD GAMES IN ABU DHABI FOR BOWLING. LARGE GROUP PHYSICAL FITNESS AND NUTRITION ACTIVITIES ARE AVAILABLE TO ALL HEALTH EDUCATION AND SUPPORT DEPARTMENT WORKS TO EMPOWER CLIENTS TO UNDERSTAND AND INDEPENDENTLY MANAGE THEIR HEALTH ISSUES. THE IMPORTANCE OF HEALTHY EATING AND GOOD PERSONAL HYGIENE IS EMPHASIZED, AND BASIC FIRST AID PROCEDURES ARE EXPLAINED. SUPPORT FROM A REGISTERED NURSE HELPS CLIENTS FEEL COMFORTABLE WITH WHAT THEY CAN DO THEMSELVES AND TO KNOW WHERE TO GO WHEN THEY NEED HELP. AS PART OF THE CLIENT'S CARE TEAM, AT TIMES THE NURSE MAY COLLABORATE WITH OTHER JESPY STAFF MEMBERS TO SUPPORT A CLIENT IN MINIMIZING HEALTH ISSUES, AT THE REQUEST OF THE PHYSICIAN, MONITOR BLOOD PRESSURE, BLOOD SUGARS, WEIGHT, ETC. FOR THOSE WITH MORE SERIOUS HEALTH ISSUES, VISIT A CLIENT IN A HOSPITAL OR NURSING HOME TO MAKE CERTAIN THAT HE OR SHE IS COMFORTABLE IN THE SETTING AND ADVOCATE ON BEHALF OF THE CLIENT WHEN NECESSARY, ESTABLISH A RAPPORT WITH CLIENT PHYSICIANS AND FACILITATE APPOINTMENT SCHEDULING FOR SERIOUS OR URGENT NEEDS, ASSIST IN HELPING THE CLIENTS FULFILL THEIR TREATMENT PLANS, AND CONDUCT GROUP WORKSHOPS ON VARIOUS HEALTH TOPICS SUCH AS HEALTHY EATING HABITS, GOOD HYGIENE TECHNIQUES, AND PREPARING FOR FLU SEASON AS WITH ALL JESPY SERVICES, THE HEALTH EDUCATION AND SUPPORT DEPARTMENT CONTRIBUTES TO EACH CLIENT'S ABILITY TO BE INDEPENDENT, SAFE, AND HEALTHY. WORK READINESS AND EMPLOYMENT ENGAGEMENT (WREE) DEPARTMENT IMPLEMENTS UP-TO-DATE BEST PRACTICES FROM ACROSS THE NATION THAT INCLUDE AN EMPHASIS ON JOB-RELATED SKILL DEVELOPMENT TRAINING, BOTH ONSITE AT JESPY AND OFFSITE, AFTER A COMPREHENSIVE WORK READINESS ASSESSMENT, DEVELOPMENT OF AN INDIVIDUAL PERFORMANCE PLAN FOR EVERY CLIENT PROVIDING ATTAINABLE GOALS REFLECTIVE OF THEIR LEVELS OF ABILITY AND INTERESTS, EXPANSION OF PARTNERSHIPS WITH COMMUNITY BUSINESSES, SYNAGOGUES, CHURCHES AND OTHER NON-PROFIT ORGANIZATIONS THAT WILL PROVIDE A VARIETY OF WORK EXPERIENCES IN WHICH CLIENTS CAN LEARN AND DEVELOP SKILLS AND CREATE MORE OPPORTUNITIES FOR OUR CLIENTS TO ENGAGE IN VOLUNTEER WORK OR INTERNSHIPS AS WELL AS PART-TIME AND FULL-TIME EMPLOYMENT, EMPLOYMENT SUPPORT THAT PROVIDES A CONSISTENT TRANSITION INTO THE WORKFORCE, WITH WREE COORDINATORS SPENDING A MAJORITY OF THEIR TIME IN THE FIELD MONITORING EACH CLIENT'S PERFORMANCE AND CONSULTING WITH HIS OR HER EMPLOYER, AND DEVELOPMENT OF GROUP OPPORTUNITIES IN WHICH CLIENTS CAN BROADEN THEIR KNOWLEDGE OF DIFFERENT WORK VENUES AND JOBS THAT MAY BE AVAILABLE TO THEM, INCLUDING IN-PERSON AND VIRTUAL WORK FAIRS, CIVIC ORGANIZATION HAPPENINGS, NON-PROFIT ASSOCIATION EVENTS, ETC.
