As a public charity, The Douglass Fund will continue to receive gifts allowed by the Trust and other agreed terms. The exclusive purpose of The Douglass Fund is to hold, obtain, invest, dispose of, expend, apply, receive and administer property, both real and personal, for charitable, educational, scientific and other purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and Treasury regulations issued pursuant thereto (referred to as the "Code"), and specifically to Support Douglas Residential College.
