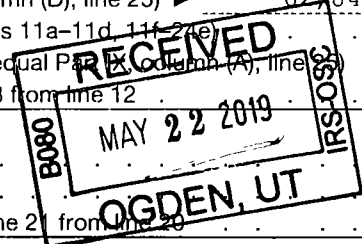

Taylor Hospice Operations Taylor Hospice provides physical, emotional, and spiritual care for terminally ill patients and their families. Taylor Hospice served a total of 76 patients in their homes in 2017-2018, and 60 patients in our inpatient facility in 2017-2018. Every patient's unique needs are assessed on an ongoing basis. Nurses, home health aides, and allied health professionals provide for the patient's clinical and other physical needs. We assist families in obtaining medicines and medical equipment and attend to patient's grooming and hygiene. All of our clinical care providers are fully See Part III, Ln 4a statement

Scholarships TCF awards multiple 4-year scholarships to high-achieving and community-involved college undergraduates pursuing academic objectives in the fields comprising Allied Health. Eighteen (18) such scholarships were awarded to the graduating high school class of 2018. The awards are for \$7,000 each, payable 50% freshman year and 50% senior year to those students who continue to excel and maintain focus in the fields of allied health. TCF also administers scholarship programs through donor-advised funds in varying amounts and for varying purposes.

4c (Code ) (Expenses \$ 291,410. including grants of \$ 133,949.) (Revenue \$ 129,614.)

Grantmaking programs through organizational budget and through donor advised and community advised fund programs. TCF assists individuals and groups to raise funds for charity in an organized way by offering to assist with marketing, administration, and treasury and bookkeeping operations for events designed to raise funds that benefit TCF programs or that will be distributed to TCF's supported charities for use in Delaware County, PA.
