WellSpan Properties Property Transfer	<p>In September of 2017, WellSpan Properties filed Articles of Division, by which WellSpan Properties was divided into itself and the following four new Pennsylvania nonprofit corporations: WSS Realty, WH Realty, YH Realty and WMG Realty. These four new Pennsylvania nonprofit corporations were each formed to carry out the same charitable purposes as WellSpan Properties. In accordance with the Articles of Division, certain parcels of real estate which were owned by WellSpan Properties prior to this reorganization were divided among the four new Pennsylvania nonprofit corporations, as follows: WSS Realty held the real estate on which the surgery and rehabilitation hospital operated by WellSpan Specialty Services is located, WH Realty held the real estate on which the building that houses the corporate offices and information technology functions of WellSpan Health, the parent entity of the WellSpan system, is located, YH Realty held the real estate at which York Hospital provides certain hospital-based ambulatory imaging services, and, WMG Realty held the real estate at which certain physician practices owned by WellSpan Medical Group are operated. WellSpan Properties retained the balance of the real estate and assets which were owned by WellSpan Properties prior to this reorganization. Immediately following this reorganization, WSS Realty was merged with and into WellSpan Specialty Services, a Pennsylvania nonprofit corporation, WH Realty was merged with and into WellSpan Health, a Pennsylvania nonprofit corporation, YH Realty was merged with and into York Hospital, a Pennsylvania nonprofit corporation, and, WMG Realty was merged with and into WellSpan Medical Group, a Pennsylvania nonprofit corporation. Effectively, the end result of this reorganization was that certain parcels of real estate which were owned by WellSpan Properties prior to this reorganization but leased to and utilized by the four surviving WellSpan corporations named above (i.e., WellSpan Specialty Services, WellSpan Health, York Hospital, York Hospital), respectively, are now instead owned by the four surviving WellSpan corporations, which continue to utilize the parcels in furtherance of their charitable purposes.</p>
