IN JANUARY, VFES HELD THE TENTH ANNUAL SPECIAL KIDS CAMP EXPO. MORE THAN 200 FAMILIES AND PROFESSIONALS FROM SOUTHEASTERN PENNSYLVANIA LEARNED ABOUT EDUCATIONAL AND RECREATIONAL SUMMER PROGRAMS OFFERED TO YOUTH AND ADULTS WITH SPECIAL NEEDS. THE VANGUARD SCHOOL IS AN APPROVED PRIVATE SCHOOL (APS) THAT PROVIDES PROGRAMS FOR STUDENTS, 4-21 YEARS OF AGE, WITH PENNSYLVANIA DEPARTMENT OF EDUCATION DESIGNATED EXCEPTIONALITIES OF AUTISM, SPEECH-LANGUAGE DISORDERS, EMOTIONAL DISTURBANCE AND/OR OTHER HEALTH IMPAIRMENT (OHI). STUDENTS WHO EXPERIENCE DEVELOPMENTAL DISABILITIES OR SOCIAL-EMOTIONAL OR BEHAVIORAL DIFFICULTIES ARE ALSO ELIGIBLE FOR OUR PROGRAM. PAES CLARIFIES STUDENTS' INTEREST IN SPECIFIC WORK AREAS, THEIR COMPETITIVENESS WITH PEERS, AND ASSESSES THEIR CURRENT BARRIERS TO FUTURE SUCCESS, AND THEN, THROUGH PRACTICE, HELPS TRANSFORM THEM TO POSITIVE WORK BEHAVIORS. THE PAES CURRICULUM HIGHLIGHTS FIVE CAREER AREAS: BUSINESS/MARKETING, CONSTRUCTION/INDUSTRIAL, CONSUMER/SERVICE, PROCESSING/PRODUCTION, AND COMPUTER/TECHNOLOGY. THE VANGUARD SCHOOL ALSO MAINTAINED PARTICIPATION IN A SCHOOL-WIDE POSITIVE BEHAVIOR SUPPORT (PBIS) PROGRAM THAT ACTIVELY ENCOURAGES STUDENTS TO ACHIEVE THEIR ACADEMIC POTENTIAL WHILE SIMULTANEOUSLY REINFORCING THEIR SOCIAL AND EMOTIONAL LEARNING SKILLS. THESE STAFF MEMBERS WILL TRAIN OTHER STAFF TO IMPLEMENT UKERU THROUGHOUT THE SCHOOL. THE VANGUARD PRE-K AND ELEMENTARY SCHOOL PROGRAM OPENED TWO NEW CLASSROOMS DURING 2017-2018. THE ELEMENTARY SCHOOL ALSO ADDED WEEKLY INSTRUCTION IN THE DAILY LIVING CENTER, AN APARTMENT-STYLE SETTING FOR STUDENTS TO PRACTICE AND MASTER DAILY LIVING SKILLS. FURTHER, TO BETTER SERVE THE NEEDS OF ITS STUDENTS, THE ELEMENTARY AND MIDDLE SCHOOLS OPENED TWO INTENSIVE THERAPEUTIC CLASSROOMS (ITC) IN FALL 2017. ITC PROVIDES STUDENTS REQUIRING INTENSIVE THERAPEUTIC, SOCIAL AND EMOTIONAL SUPPORT WITH AN INTERDISCIPLINARY TEAM THAT USES EVIDENCE-BASED BEHAVIORAL AND EMOTIONAL REGULATION AND PROBLEM-SOLVING SKILLS TO MANAGE FRUSTRATION AND ANGER. THE VANGUARD MIDDLE SCHOOL DEVELOPED A STRUCTURED LUNCH PROGRAM (WHICH PROVIDED A STRUCTURED INTERACTION AND SOCIAL SKILLS DEVELOPMENT DURING THE LUNCH/RECESS PERIOD). THE MIDDLE SCHOOL ALSO INTEGRATED THE PATTAAN AUTISM INITIATIVE TRAINING INTO OUR MORE INTENSIVE CLASSROOMS. THE HIGH SCHOOL CONTINUES EMPHASIS ON THE DEVELOPMENT OF ACADEMIC AND SOCIAL SKILLS, AND THE TRANSITION TO ADULTHOOD AND INDEPENDENCE. AS SUCH, HIGH SCHOOL FACULTY EXTENDED THE LIFE CAREER AND COMMUNITY EDUCATION (LCCE) CURRICULUM TO THE ENTIRE HIGH SCHOOL DURING THE 2017-18 SCHOOL YEAR. LCCE INCLUDES ACADEMIC INSTRUCTION USING REAL-WORLD MODELS. STUDENTS CONTINUED TO PARTICIPATE IN OFF-CAMPUS, COMMUNITY-BASED INSTRUCTION AT LOCAL BUSINESSES. THE VANGUARD TRANSITION CENTER (VTC) OFFERS POST-SECONDARY EDUCATION SUPPORT, CAREER PREPARATION, COMMUNITY-BASED VOCATIONAL TRAINING AND SOCIAL AND DAILY LIVING SKILLS DEVELOPMENT TO YOUNG ADULTS. STUDENTS ALSO PARTICIPATE IN COUNSELING, SELF-ADVOCACY TRAINING, COMMUNITY-BASED ACTIVITIES AND RECREATIONAL OPPORTUNITIES. IN 2017-18, THE PROGRAM HIRED A COMMUNITY-BASED VOCATIONAL TRAINING SUPERVISOR AND TWO NEW JOB COACHES. IT ALSO PARTNERED WITH NEW LOCAL BUSINESSES TO GIVE STUDENTS ADDITIONAL VOCATIONAL TRAINING OPPORTUNITIES.
