The North Carolina Museum of Art Foundation, Inc. provides the majority of financial support needed for education and curatorial programming of the Museum of Art including support for statewide and museum-based education programming, special traveling art exhibitions, supplemental art conservation funds, and public programming.

### **Form 990, Part III, Line 4c:**

The North Carolina Museum of Art Foundation Inc owns 34 acres of the street frontage of the museum and has made significant investments in developing this property as the garden gateway to the Museum and Museum Park which sits on 130 acres of state property. The Foundation completed a \$13M park expansion project during the 2016/17 fiscal year, with a formal park opening in November of 2016. This investment was capitalized as land improvements. Continued investment in park trails, structures, art and ongoing maintenance can be expected for years to come.

The most recent consulting agreement commenced on July 1, 2017 and was for a period of fifteen months ending September 30, 2018. Under this agreement, Dr. Wheeler received quarterly consulting fees of \$85,000 paid by the Foundation. Dr. Wheeler retired as Director of the North Carolina Museum of Art in November 2018. |
