In partnership with generous donors, Sun Health Foundation provided \$4,063,569 in philanthropic support to Banner Boswell Medical Center (a nationally recognized 410-bed acute care hospital), Banner Del E. Webb Medical Center (a 304-bed nationally recognized acute care hospital), Banner Sun Health Research Institute with research focus on diseases of the aging, and other community health initiatives including Nursing Education, Banner Olive Branch Senior Center, La Loma Care Center, Grandview Terrace Care Center, Grandview Terrace Memory Support Suites, the Center for Health and Wellbeing, Care Transitions Program, and Community Education. The Foundation also directs funds from its resale gift shops to Banner Boswell and Del E. Webb Medical Centers. The Sun City West resale shop, in partnership with the Sun City West Foundation, directs certain proceeds for localized transportation services for area seniors.
