UFM Community Learning Center is a creative educational program serving Kansas State University, the Manhattan, KS area and the state of Kansas. UFM provides opportunities for lifelong learning and idea exchange. UFM also serves as a catalyst and host for new programs and services that enhance the quality of life for all.

UFM Educational Program: This is UFM's largest program and primary mission activity. The educational program offers a wide variety of noncredit and credit courses and workshops. In FY18, UFM offered 1,292 noncredit courses and 225 courses offered for credit through Kansas State University. 5,351 (unduplicated) persons took noncredit classes and another 1,679 received K-State credit. Class topics included aquatics, creative free time, foods and nutrition, earth and nature, health and fitness, and recreation. UFM is the sole Licensed Training Provider for the American Red Cross in Manhattan, KS and is the largest provider in Kansas. UFM collaborates with many other organizations to serve the community and participates in community awareness activities. UFM continued to host the Osher Lifelong Learning Institute classes in collaboration with the University of Kansas and K State Global Campus. This year we had 729 enrollments in classes offered during the year. UFM hosted swimming classes for USD#383's Summer Fun Camp and hosted Talk20 MHK. These brought almost 300 participants. UFM serves as the host for noncampus groups using the KSU Ahearn Complex. 5,272 attended events in FY18.

4b (Code:) (Expenses \$ 123,356 including grants of \$ 0) (Revenue \$ 123,794)

Manhattan Risk Prevention Coalition (MARPC): UFM receives and administers funds on behalf of MARPC, a coalition of 12 community sector representative organizations and individuals. The focus of the organization is risk reduction and prevention among youth, especially in the area of drug/alcohol use issues and prevention activities. In FY18, MARPC received a federal Drug Free Communities grant. The focus of the grant was capacity building, improving the organization, and improving function of the coalition. Funding was used for a media campaign on social hosting, responsible alcohol use and not providing alcohol to minors. MARPC surveyed members to assess other growing areas of concern in the community. MARPC coordinated Sticker Shock events in Manhattan and at Ft. Riley. About 60 volunteers put stickers, focused on not providing alcohol to minors, on 10,000 packaged alcohol products in Manhattan and Ft. Riley liquor stores. MARPC also participated in public events, sharing information for parents. 956 participated in MARPC events.

UFM Teen Mentoring Program: The Teen Mentoring Program offers a structured program of support and life skills to youth in grades 7-12. Project goals for the teens include learning positive life skills and focusing on primary prevention and intervention activities. Students from Kansas State University serve as mentors. Participant referrals come from the schools, community corrections, parents and teen participants who bring their friends. This program is funded by the City of Manhattan Special Alcohol Fund. In FY18, the program offered three after school groups a week. 60 youth were served and 40 K-State students served as mentors.

Part III.4d.1 Manhattan Community Garden Expenses: \$15,333 Grants: \$0 Revenue: \$20,035

Low cost garden plots are available to Manhattan and Riley County residents. Print newsletters are produced three times a year during the garden season. An electronic newsletter is sent weekly. Power tools, hoses, hand tools, and some seeds are provided. Land is leased from the City of Manhattan, KS, and Riley County, KS. In FY18, 173 families gardened 280 plots. Revenue appears to be high because plot signups overlap two fiscal years with much of the revenue for the following year collected in the current year. Excess funds are routinely set aside for future garden development and for equipment replacement purchases.

Part III.4d.2. Manhattan Nonviolence Initiative Expenses: \$19,261 Grants: \$0 Revenue: \$28,335

This is a new project finishing its first year in FY18. The focus of the program is to make and maintain a safe and equitable campus and community through the practice of everyday nonviolence. Activities included creating community conversations, gatherings, and participating in collaborative meetings with others interested in civil discourse on community issues. Specific activities included the Harmony in the "Hatt music festival, Empty Bowls to support food insecurity, Kindness Rocks and teaching Peaceful Communication classes and promoting the Season For Nonviolence. Participation was 2,145.

Part III. 3d. 3 Project EXCELL (Extending College Education for Lifelong Learning) Expenses: \$14,539 Grants: \$0 Revenue: \$15,849

Project EXCELL provides area adults with mild developmental/intellectual disabilities enrichment classes in a college-like setting. Traditional college students serve as mentors and classroom aides. Classes are held Saturday mornings during the fall and spring semesters. In FY18, 74 students were enrolled and 200 KSU students assisted.

Part III. 4d. 4. Lou Douglas Lecture Series Expenses: \$ 26,650 Grants: \$0 Revenue: \$11,330

This lecture series brings speakers to the Kansas State University campus. The theme of the series is social justice, human rights, and world peace. In addition to the evening lecture, speakers often visit K-State classes, meet with students and participate in campus and community events. In FY18, speakers included Keith Edwards, addressing sexual violence on campus, Charles Blow speaking on perceptions of the media and Peter Bratt, sharing his documentary, Dolores. Over 1,500 people attended the lectures.

Part III.4d.5. Short Projects Expenses: \$0 Grants: \$0 Revenue: \$1,000

UFM Short Projects is an account used to support contributions to UFM solar energy projects and small community projects. In FY18, UFM received a grant of \$1,000 to distribute as scholarships to area youth who wish to take tennis lessons. No requests were received in that year.
