ALTHOUGH THE COLLEGE'S TUITION IS THE LOWEST IN NORTHEAST OHIO, THERE ARE STUDENTS IN OUR COMMUNITY WHO, WITHOUT SOME FINANCIAL ASSISTANCE, ARE UNABLE TO ACCESS OR CONTINUE THEIR EDUCATION. SCHOLARSHIPS INCREASE ACCESS TO HIGHER EDUCATION AND SUPPORT THE ULTIMATE GOAL OF EXPEDITING STUDENT TRANSITION THROUGH COLLEGE AND REDUCING THEIR TIME TO GRADUATION. SCHOLARSHIPS HAVE ENABLED THOUSANDS OF STUDENTS TO ACCESS AND OBTAIN THEIR COLLEGE EDUCATION. OVER A FIVE YEAR PERIOD (FY2014-2018), 11,970 SCHOLARSHIPS TOTALING \$11.8 MILLION WERE DISTRIBUTED TO TRI-C STUDENTS. THE AVERAGE SCHOLARSHIP WAS \$986.
