OTHER PROGRAM SERVICES EXPENDITURES INCLUDE PAYMENTS TO SUPPORT STUDENT ATHLETICS AND OPERATING EXPENSES OF THE FOUNDATION. IN FISCAL YEAR 2018, THE FOUNDATION HAD 26 EMPLOYEES WITH OFFICES IN FAIRBANKS AND ANCHORAGE, ALASKA. THE BOARD OF REGENTS OF THE UNIVERSITY OF ALASKA HAS RECOGNIZED THE UNIVERSITY OF ALASKA FOUNDATION AS THE ENTITY TO MANAGE PRIVATE GIFTS MADE TO SUPPORT ALL CAMPUSES OF THE UNIVERSITY OF ALASKA SYSTEM. IN ADDITION, THE FOUNDATION MANAGES THE INVESTABLE ASSETS OF UA'S LAND GRANT TRUST FUND. THE FOUNDATION IS RESPONSIBLE FOR GIFT ACCEPTANCE, INVESTMENT AND DISBURSEMENT TO UA, ENSURING PRIVATE CONTRIBUTIONS ARE USED IN ACCORDANCE WITH DONORS' WISHES. MORE THAN 1600 SEPARATE FUNDS ARE MANAGED AND INVESTED FOR THE BENEFIT OF THE UNIVERSITY. THE FOUNDATION'S OPERATIONS ARE FUNDED BY A ONE-TIME ADMINISTRATIVE FEE OF 1% ON ENDOWED GIFTS, 5% ON NON-ENDOWED GIFTS, AN ANNUAL 1% FEE ON THE ENDOWMENT FUNDS, AND AN ANNUAL 5% FEE ON THE UNIVERSITY OF ALASKA LAND GRANT TRUST FUND.
