Reason for Amendment	Form 990 was completed prior to the completion of its audit. We are filing an amended return to reflect the changes to the numbers reported on the 990 as a result of the finalized financial reports in the audit. Total expenses decreased by \$9,572. Functional expense allocations changed as well. There was a \$6,647 increase in Program service expenses, a \$13,310 decrease in Management and General expenses, and a \$2,909 decrease in Fundraising expenses. There were also some changes to the reconciliation of net assets. There is no longer a prior period adjustment for (\$145). Other changes in net assets or fund balances increased by \$15,997 from a change in the value of CRT. The Schedule A Public support percentage for 2017 decreased by 0.03% from a \$2,600 increase in amounts received from disqualified persons. The Schedule D was amended to report changes in the endowment funds activity for a cumulative increase in the end of year balance of \$15,997. Land, Buildings, and equipment also changed to report depreciation and other changes in capitalized assets. Other Asset investments were added to Part IX Other Assets on schedule D. Parts XI and XII were filled out to reconcile to the audited financial statements.
