CCMA mobilizes the collective commitment of and capacity of higher education to actively advance our communities through civic and community engagement throughout the Maryland, DC and Delaware region. CCMA serves its member institutions through networking, grants, resources and programs with the goal of developing deeper campus-community partnerships which improve community life.

CCMA AmeriCorps VISTA grant. CCMA addresses and alleviates poverty in the Maryland-DC-Delaware region through the federally funded CCMA AmeriCorps VISTA Grant --> <https://midatlantic.compact.org/grants-and-awards/amicorp-vista/>. Through this grant CCMA provides up to 38 full time "positions" to develop and expand anti-poverty partnerships between higher education institution members and community-based organizations, non-profits, or local schools and school systems in the region. Through data from the annual survey we estimate that member institutions' students contribute a minimum of \$600 million in services annually to the region. The VISTA grant alone is a value of \$2 million to our members. Our projects represent a smorgasbord of foci ranging from financial literacy, work force development, mentoring, veteran initiatives, ESOL programming, college access, college completion, to food security. CCMA also develops and runs a leadership and professional development program for the AmeriCorps members who are giving a year or more of their lives to build these partnerships and improve our communities. CCMA VISTA projects expand the capacity of regional non-profits and institutions of higher education to transform and empower first-generation college students, community members, and K-12 youth.

Professional development institutes, workshops, retreats, awards, surveys and mini-grants:

Another area of CCMA's impact is providing professional development opportunities for faculty, staff, students and other constituents in its membership. CCMA currently sponsors a Service-Learning and Civic Engagement Conference for 300+ faculty and students, annual retreats including a "Practitioners' Retreat" for engagement professionals, and numerous workshops on service-learning, grant writing, effective team building, volunteer recruitment, professional writing and (federal) report writing, etc. CCMA provides mini-grants to promote faculty development, building a culture of engagement on a campus, community-based learning, and rewarding the scholarship of engagement in the promotion and tenure process.

CCMA also provides competitive mini-grants for student groups which wish to expand a program with a community partner organization. CCMA coordinates an annual awards program which highlights exceptional leadership and work in the area of service-learning and civic engagement, administers national award programs (such as the Campus Compact Newman Civic Fellowship award). Finally, CCMA administers an annual national member survey and co-sponsors other regional and national conferences.

Based on the collective agreement of 44 higher education institutions to partner with K-12 schools and school systems to enhance the P20 (PreK-higher education) pipeline for college readiness, career readiness and civic and community readiness, CCMA convened a P20 CONNECTS Leadership Team (LT). The LT works closely with K-12 partners such as the Maryland State Department of Education, the Public School Superintendents Association of Maryland and the District of Columbia Public Schools and Charter Schools to, together, discern how to better "connect the dots" at the policy-level to enhance the pipeline for college, career, and civic readiness. The team issued a white paper on P20 CONNECTS: College, Career and Civic Readiness through Civic Education and a P20 Connects Five Year Action Plan. The work of P20 CONNECTS is moved forward through annual convening of our member institutions' presidents and area school system superintendents. CCMA has mobilized regional conversations and five pilot partnerships to promote best practices. CCMA has recruited a full-time AmeriCorps VISTA member to assist in mobilizing P20 CONNECTS (a grant valued at \$50,000) and has coordinated the expansion of a P20 CONNECTS website, e-newsletter, print newsletter and further resources.
