Line 8 Other Revenues \$14,650

The total in other revenues consist of student paid portion of various field trips and activities. The Hyalite Elementary PAC spend more than received on these activities, however students were asked to contribute a portion of the cost. The receipt consisted of activities related to classroom enrichment, world language, STEAM club, parent education, arts activities, and fitness activities.

Line 10 Grant and Similar Amounts Paid \$83,748

This consists of all amounts paid out to various programs. The largest portion of which is explained in Part 3. Two other notable expenses were payment for Literacy fund raiser we held with another school in which half of the proceed went to Irving Elementary School and half went to Hyalite Elementary for purchasing library books and equipment. The amount paid to Irving Elementary was \$7,454. The other notable expense was amounts paid to multiple other schools for their students participation in a run. The total amount paid to other schools was \$4,841 based on the number of students participating from each school.
