Concordia Lutheran Ministries of Pittsburgh operates Concordia of the South Hills, which is one of the premier continuing care communities for seniors in the greater Pittsburgh area. The skilled nursing component of the Concordia of the South Hills operation, at the time of this filing, has a rating of five stars, the highest rating that the Centers for Medicare and Medicaid Services award. Benevolent care is also a core tenant of the mission of Concordia Lutheran Ministries. With the focus on charity care being so important to Concordia, the parent organization (Concordia Lutheran Ministries) provided a gift of \$1,000,000 to the organization upon the acquisition of Concordia of the South Hills to establish the Caring Fund of which a portion of is disbursed every year for the benevolent care of residents at the facility as well as improvements to the facility to increase resident quality of life. In April of 2018, the organization expanded the scope of its skilled nursing operations by acquiring the skilled nursing facility now known as Concordia at Villa St. Joseph. The facility is a wonderful compliment to the existing operations as it allows the organization to serve a greater number of patients in the Pittsburgh area and it allows the organization the opportunity to serve a Medical Assistance population. Concordia at Villa St. Joseph, at the time of this filing, also has been awarded a five star rating by Centers for Medicare and Medicaid Services.

Form 990, Part III, Line 4b:

When Concordia of the South Hills was acquired, the independent living portion of the community was less than half filled and had not had a new resident join the community for over two years. Since the acquisition by Concordia, the independent living portion of the community has been fully occupied and the community now has a significant wait list for entry. When the community was acquired, Concordia did not receive any of the entrance fees that the former owner had collected. Even though Concordia did not receive the proceeds, in good faith, the organization has honored the Life Care benefit of all the legacy residents. In addition to honoring the benefit, the organization also did not raise the rates of any of the pre-acquisition residents for three years after acquisition. Because providing a social environment is very important to Concordia, the organization tripled the size of its community hall, now all residents of community can attend meetings, events, and activities in the shared space at the same time. The facility also opens its doors to the surrounding community to be able to use this space for community gatherings. The organization also invites local vendors and the community to the facility for the annual holiday bazaar where vendors, residents, and community members have the opportunity to interact.

Form 990, Part III, Line 4c:

In addition to Concordia of the South Hills, Concordia Lutheran Ministries of Pittsburgh also encompasses the stand alone personal care operations of Concordia of Cranberry, Fox Chapel, Franklin Park, & Wexford. Personal care is the largest component of the organization's operation with a combined total of 371 licensed personal care beds spread between its five facilities. Those residents in our care receive assistance with daily activities, three chef-inspired meals every day, regular housekeeping and laundry services, and an abundance of engaging activities. Concordia Lutheran Ministries also established the Benevolent Care Fund with a gift of \$500,000 to help provide charitable care to the residents of the stand alone personal care facilities. Through the use of the Caring Fund and Benevolent Care Fund in conjunction with general charitable care by the organization, the organization provided nearly one million dollars in benevolent care during this fiscal year alone. The individual organizations have also sponsored Rotary Clubs and various sports teams in their local markets, as well as supported local fire departments with donations to organizations such as the Mount Lebanon Volunteer Fire Department and the Franklin Park Volunteer Fire Department. Memory Support and dementia care is also very important to the organization with two of its facilities providing dedicated memory support care, in addition to providing care ourselves, the organization is also a sponsor of and a donor to the Pittsburgh, PA chapter of the Alzheimer's Association.
