The Newberry Consort brings together singers and instrumentalists of the highest caliber to create accessible, historically informed performances of early music and provides a window into earlier times and cultures through performances, education and research.

Sacred Love: Songs of the Sephardim. When in 1492, under an edict of expulsion, the Jews of Spain left to wander throughout the Mediterranean, they took their language and songs with them ultimately settling in parts of the Ottoman Empire, Europe and the New World. In addition to the haunting songs of the Sephardim, this concert also included songs of the three faiths, Islam, Christianity, and Judaism, which had long coexisted and traded cultural influences prior to the expulsion of all but Christians. Visuals provided a copy of the original edict, plus translations and illustrations from manuscripts.

4b (Code: 711130) (Expenses \$ 44,733 including grants of \$) (Revenue \$ 14,542)

Forbidden Love: The Passion of Helise and Abelard. Heloise and Abelard are famous both for their doomed love affair and the letters they exchanged after their separation. Recent scholarship identifies early formerly anonymous letters twelfth century letters as being authored by the lovers at the outset of their relationship. This concert focused on these earlier letters both by presenting music familiar and composed by both Heloise and Abelard while costumed actors read from these earlier letters. Visuals provided translations along with pictures of the original manuscripts.

4c (Code: 711130) (Expenses \$ 45,870 including grants of \$) (Revenue \$ 13,749)

Dangerous Love: Playing with Fire. Music of 17th century Italy, already virtuosic, was further enhanced by the improvised ornamentation of the singers and players. This concert, focusing on text about love, provided ample opportunity for the members of the ensemble to display their skills.
