Accordingly, we have not counted the citizens we mobilized as Network volunteers. The volunteers reported here are our board members, who serve without compensation.

However, the Network's practice is to inform all donors, whether or not they are members, that their contributions are not tax deductible as charitable contributions or as business expenses.

It is empowered to review and advise on decisions of management in between full board meetings, consistent with the direction set by the full board. It has no power to amend the Network's governing documents, dissolve or merge the Network, approve the sale or exchange of any assets of the corporation, or elect or remove directors or officers.

The executive committee serves primarily to advise management, and thus does not typically exercise board powers to pass resolutions with binding effect.

The President/Executive Director reviews and approves all staff compensation.
