





## **RESTATEDED BYLAWS**

**of the**

**1Force NV Assistance Fund, Inc.**

**A Nevada non-profit corporation**

Comes now the Board of Trustees of 1Force NV Assistance Fund, Inc., formerly known as the Assistance Fund of the Nevada Department of Public Safety Association, Inc., and sets forth the following Bylaws:

### **ARTICLE I**

#### **Name, Offices, and Administration and Management**

**SECTION 1. Name.** The Corporation shall be known as the 1Force NV Assistance Fund, Inc., and for purposes of these Bylaws is hereinafter referred to as the "Corporation."

**SECTION 2. Offices.** The Board of Trustees (hereinafter the "Board") may change the principle office of the Corporation to other locations in Nevada from time to time. The Corporation may also have offices at such other places within and without the State of Nevada as the Board may from time to time determine is appropriate.

**SECTION 3. Administration.** The administration of the Corporation is vested in the Board.

**SECTION 4. Management and Operation.** The management and operation of the Corporation is delegated by the Board to the Corporate Officers.

**SECTION 5. Liability.** The Board and the Corporate Officers may not be held liable for their actions as Board members or Corporate Officers except in those instances of intentional misconduct, fraud, or a knowing violation of the law.

### **ARTICLE II**

#### **Statement of Purpose**

This Corporation has been created and organized as a non-profit corporation under the laws of the State of Nevada. It is formed exclusively for charitable, educational, and scientific purposes within the meaning of 501(c)(3) of the Internal Revenue Code and shall include, for

such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code (I.R.C. or other corresponding section of any future federal tax code).

The Corporation shall also transact any lawful enterprise or endeavor in accordance and furtherance of the foregoing purposes, provided that all such enterprises and endeavors shall be consistent with the Corporation's operation as a non-profit corporation and the powers provided in Chapter 82 of the Nevada Revised Statutes.

### **ARTICLE III**

#### **Non-profit Status**

It is intended that the purposes and activities of the Corporation, as well as any disposition of its assets, shall at all times conform to Section 501(c)(3) of the I.R.C. (or the corresponding provision of any future federal tax code) as those laws apply to exempt organizations.

No member of the Board or Officer of the Corporation shall have any right, title, or interest in or to any property or assets of the Corporation, either prior to or at the time of any liquidation or dissolution of the Corporation, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of the Corporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Bylaws, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the I.R.C. (or the corresponding section of any future federal tax code), or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the I.R.C. (or the corresponding section of any future federal tax code).

## **ARTICLE IV**

### **Mission Statement**

The Corporation has been formed to provide:

1. Financial assistance to Nevada Highway Patrol officers, their spouses and families, or to individual Nevada Highway Patrol officers without spouses/families, who are or were employed by the State of Nevada as a highway patrol officer and were injured or die (a) in the line of duty, (b) while going to or from an official duty post, or (c) under other circumstances which merit assistance.
2. Financial assistance to other public safety personnel or commissioned peace officers, their spouses or families, or to individual public safety or peace officers without spouses/families, employed by the state of Nevada and other local law enforcement agencies of Nevada, and from time to time, those employed by other state and local law enforcement agencies, who are injured or die (a) in the line of duty, (b) while going to or from an official duty post, or (c) under other circumstances which merit assistance.
3. Education and training of Nevada Highway Patrol and other public safety personnel, commissioned peace officers, or to individual public safety or peace officers employed by state and local law enforcement agencies of this state, and from time to time, retired public safety personnel and others, to help said patrol officers, law enforcement personnel, or persons to be more effective in doing their jobs, and to promote and improve the safety of said patrol officers, public safety personnel and such persons. One goal of such education and training would be to argument the type of education and training the patrol officers, public safety personnel, and other persons receive or have received. Such education and training may include, but not be limited to, de-escalation strategies and techniques, legal requirements in use of force situations, close contact self defense, tactical and advanced tactical handgun, shoot gun, and taser training, and firearms accuracy practice to include appropriate ammunition provided to offset the costs to the patrol officer.

The Corporation reserves the right to determine on an ad hoc basis (1) the situations

and circumstances where Nevada Highway Patrol officers, their spouses or families or other law enforcement or members of the public may need assistance due to illness, death, or injury, and (2) the education and training made available to help patrol officers, law enforcement personnel, or other persons be more effective in doing their jobs, and to promote and improve the safety of said officers and persons.

The Corporation intends to accomplish its goals and maintain its operations through the use of monies, equipment and property either contributed for its use or purchased on its own. In order to ensure the deductibility for income tax purposes of contributions made to it and the tax-exempt character of any income it may earn, the Corporation intends to retain its qualification as an I.R.C. Section 501(c)(3) tax-exempt organization, contributions to which will be deductible under I.R.C. Section 170(b)(1)(A).

The Corporation may, but is not required to, set forth criteria as to who is entitled to receive assistance from the Corporation.

## **ARTICLE V**

### **Board of Trustees**

**SECTION 1. Composition.** There shall be five (5) members of the Board of Trustees.

The Board shall be comprised of the following individuals:

- A) Either the President or Vice President of Nevada Highway Patrol Association, Inc. ("NHPA");
- B) Secretary/Treasurer of NHPA;
- C) Administrative Assistant of NHPA;
- D) Two at-large Trustees appointed by the Board.

In the event an individual does not desire to exercise this responsibility, he or she may decline the appointment in writing to the Board, in which event his or her position on the Board will be filled by an additional at-large member. The Board shall have the power to delegate to officers and agents the performance of duties and the exercise of powers otherwise vested in the Board.

SECTION 2. Term. Those individuals serving on the Board of Trustees as a result of their elected or appointed position, as the case may be, with NHPA shall serve for a term that is equivalent to their term of office with NHPA. By example, if the term of office of the president of NHPA is two years and he or she serves on the Board of the Corporations then his or her term as a Board member will be two years. The term for the at-large Trustees shall be for a period of two (2) years from the date of the appointment as an at-large Trustee.

SECTION 3. Resignations. Any Trustee may resign at any time, giving written notice of such resignation to the Board. In the event any individual is acting in the position of a Board member as a result of his position as an officer of NHPA and he or she resigns from NHPA then he or she shall also resign from the Corporation.

SECTION 4. Vacancy. When an individual no longer holds one of the above positions, that Trustee's position shall become vacant. Any vacancy in the Board of Trustees shall be filled through an appointment by the Board at the time the vacancy occurs. The person appointed to fill a vacant position shall hold a position as a Board member and serve for the period of time remaining for the position that was vacated.

SECTION 5. Compensation. Trustees shall not receive any salary for their services. Nothing shall preclude any Trustee from serving the Corporation in any other capacity and receiving compensation therefor.

SECTION 6. Special Meetings. Special meetings of the Board may be called by the President or Vice-President, and must be called by either of them on written request of any two (2) members of the Board. The Officer or Trustee calling the meeting shall fix the time and place for the holding of the meeting.

SECTION 7. Notice of Meetings. Notice of all meetings of the Board shall be given by mail at least three (3) days before the meeting or email, text or telephonic notice of the same at least one (1) day before the meeting, such notice to be mailed, emailed, texted or faxed or phoned to the last known address of the Trustee.

Notice of any meeting may be waived by any Trustee.

Regular meetings of the Board may be held without notice if a regular time and place has been previously specified for the holding of such meetings. Any business may be transacted at any Board meeting. The Secretary shall maintain minutes of the meeting.

SECTION 8. Place of Meeting. The Board shall hold their meetings at such time and place as may be specified in the notice for the call of the meeting, or at such place as shall be the regularly designated meeting place.

SECTION 9. Action Without a Meeting. Any action required or permitted to be taken at any meeting of the Board or of any Committee thereof may be taken without a formal meeting if a written consent thereto is signed by a majority of the members of the Board or of such Committee. Such written consent shall be filed with the minutes of the preceding meeting of the Board or Committee. Members of the Board or of any Committee, may participate in a meeting of such Board or Committee by means of a conference call or a similar communications method by which all persons participating in the meeting can hear each other and such participation constitutes presence, in person, at such meeting.

SECTION 10. Quorum. At all meetings of the Board, a majority of the trustees shall be necessary and the act of a majority of the Trustees present at any meeting at which there is a quorum shall be the act of the Board, except as may be otherwise specifically provided by statute, the Articles of Incorporation of this Corporation, or these Bylaws. If at any meeting there is less than a quorum present, a majority of those present may adjourn the meeting from time to time, and the Secretary shall notify any absent Trustees of the time and place of such adjourned meetings. Notwithstanding the foregoing, if all of the Trustees shall sign a written ratification of actions taken at any meeting, then such actions shall be and constitute the valid actions of the Corporation, whether or not a quorum of Trustees, as defined herein, was actually present at the meeting.

SECTION 11. Committees. The Board may appoint a committee or committees to consider and act upon any particular matter which may be presented to the Corporation. Each committee shall fix its own times, places, and notices of meetings. Each committee shall keep

a record of all its proceedings and report to the Board and/or the Officers of the Corporation regarding the actions of the committee or committees.

SECTION 12. Additional Rules and Regulations. The Trustees may adopt such additional procedures for the administration of the affairs of the Corporation as the conduct of its business shall require, but such procedures shall not be inconsistent with any statute, the Articles of Incorporation of this Corporation, or these Bylaws

## ARTICLE VI

### Officers

SECTION 1. Offices. The Officers of the Corporation shall be a President, a Vice-President, a Secretary, and a Treasurer. The Immediate Past President shall be a "pro-tem" Officer and may only vote in the event of a tie-breaking situation. The offices of Secretary and Treasurer may be held by the same person.

SECTION 2. Election, Term of Office, and Qualifications. The positions of President, Vice-President, Secretary, and Treasurer shall be appointed by the Board for a two (2) year term of office. Any appointed officer may be re-appointed. The appointed officers need not be commissioned peace officers except that at least the President and/or Vice-President must be a commissioned peace officer.

The Board may appoint or elect such other officers as it shall deem necessary for the proper conduct of the business and affairs of the corporation and the accomplishment of the purposes of the Corporation.

SECTION 3. President. The President shall (a) preside at all meetings of the Officers, and (b) supervise the operation and affairs of the Corporation. The President may sign any deeds, mortgages, deeds of trust, notes, bonds, contracts, indentures, or other instruments authorized by the Board to be executed, except in cases in which the signing and execution thereof shall be expressly delegated by the Board or by these Bylaws to some other officer or agent of the Corporation, or shall be required by law to be otherwise

signed or executed. The President shall do and perform such other duties of the Office of President as may be assigned by the Board.

SECTION 4. Vice-President. The primary duties of the Vice-President are to assist the President in the operation of the Corporation. In the event of the absence or disability of the President, the Vice-President shall perform the duties of the President. The Vice-President will perform such other duties as may be assigned by the Board.

SECTION 5. Secretary. The Secretary shall (a) have charge of the books, records, and papers of the Corporation, (b) have custody of the Corporate Seal, (c) attend and keep the minutes of all the meetings of the Board and of the Officers and (d) maintain a current list of the members of the Board and Officers. The Secretary is responsible for all the normal duties prescribed for the Office of Secretary and any other such duties as designated by the Board.

SECTION 6. Treasurer. The Treasurer shall (a) have charge and custody of and be responsible for all funds and securities of the Corporation, (b) be responsible for the receipt of monies and the issuance of necessary receipts for the payment of monies by or to the Corporation, and (c) be responsible for the deposit of all monies received in the name of the Corporation in such bank or banks as shall be selected by the Corporation. The Treasurer is responsible for all the other normal duties incident to the Office of Treasurer and any other such duties as designated by the Board.

SECTION 7. Compensation. The Officers shall not receive any salary for their services. Nothing shall preclude any Officer from serving the Corporation in any other capacity and receiving compensation therefor.

SECTION 8. Meetings. The Officers will meet at a regular time and place as established by the President. Regular meetings of the Officers may be held without notice if a time and place has been previously specified for the holding of such meetings. In the event of a change of meeting place or time, or if calling a special meeting, Officers shall be given at least three (3) days notice before the meeting or by telephoning notice of the same at least

one (1) day before the meeting. Such notice shall be mailed, emailed, faxed, or phoned to the last known address of the Officer.

SECTION 9. Quorum. At all meetings of the Officers, a majority of the Officers shall be necessary and the act of a majority of the Officers shall constitute a quorum. The Officers will have one vote each except for the Immediate Past President who will only have a vote in the event of a tie. In the event the individual holds the office of Secretary and Treasurer, that individual will have only one (1) vote.

In the event there is less than a quorum present and an officer is available to participate in the meeting by telephone, this procedure is acceptable and action taken in this manner will be valid if the total number of officers present and in telephone communications make up a quorum. If a quorum cannot be obtained, a majority of those present may adjourn the meeting.

SECTION 10. Vote on Disbursement of Funds. A simple majority of affirmative votes by the Officers is necessary for disbursement of funds, except for single expenditures exceeding Ten Thousand Dollars (\$10,000), items having a residual cost exceeding Twenty Thousand Dollars (\$20,000) or having permanent and long range effect on the Corporation, which items must receive an affirmative vote of two-thirds (2/3) of the Officers.

SECTION 11. Vacancies. Any vacancy in an office shall be filled through an appointment by the Board at the time the vacancy occurs. The person appointed to fill a vacant position shall hold office and serve for the period of time remaining for the position that was vacated.

SECTION 12. Removal. Any Officer may be removed from office with or without cause by an affirmative vote of a majority vote of the Board of Trustees at any regular or special meeting called for that purpose

SECTION 13. General Duties. The Officers will, at their regular meetings handle the Operation and Management of the Corporation. The agenda may include, but not be limited

to, matters whereby the Corporation may help in the safety, well-being, and morale of the individuals the Corporation seeks to assist.

SECTION 14. Operating Procedures and Standing Motions. The Officers may establish procedures to aid the Officers in efficiently, effectively, and consistently running the affairs of the Corporation, which shall not be considered part of the official Bylaws of this Organization and the Officers shall not be bound by them legally if it can be shown that it is for the best interest of the Corporation not to adhere to them. They may be deleted, modified, temporarily set aside, or added to at any time by a majority vote of the Officers.

Any motion or action that will be of a permanent or long range nature and that tends to effect the operations of the Corporation or can be considered binding to subsequent Officers and Board Members, shall be classified as a "Standing Motion." Procedures for approval of Standing Motions will be outlined in the operation procedures and must comply with Section 5. Approved Standing Motions will become an Appendix to any procedures manual. Standing Motions will be reviewed annually at the March meeting to insure their current effectiveness or necessity to incorporate in the Bylaws, if of a permanent nature.

SECTION 15. Bonds. The Treasurer and any other officer or agent of the Corporation charged with responsibility for the custody of any of its funds or property shall give bond in such sum and with such surety as the Board or Officers shall determine. If a bond is required by the Board or Officers for the Treasurer, the cost of such bond will be borne by the Corporation.

SECTION 16. Agents and Employees. The powers, duties, and compensation of agents and employees of the Corporation shall be fixed by the Officers.

## ARTICLE VII

### Books and Records

SECTION 1. Books and Records. The Corporation shall keep correct and complete books and records of accounts and shall also keep minutes of the proceedings of the Board and its Officers and shall keep at its principal office a record giving the names and addresses

of the members of the Board and the Officers of the Corporation entitled to vote. All books and records of the Corporation may be inspected by any member, or the member's agent or attorney, for any proper purpose at any reasonable time.

SECTION 2. Maintenance of Records. Records of the Corporation will be maintained by the appropriate Officers for a period of at least 7 years as follows: the previous two (2) calendar years, maintain all records of disbursements, correspondence, receipts, bank and financial statements and minutes of all meetings held; previous calendar years, three through seven, maintain either the records themselves or a summarized report of receipts, disbursements, and actions of the Board and Officers meetings. An annual Treasurer's report showing receipts and disbursements will be maintained as a permanent record of the Corporation. Tax statements will be retained as required by current law.

SECTION 3. Corporate Seal. The corporate seal shall have inscribed thereon the name of the Corporation, the year of its organization, and the words "Corporate Seal, Nevada." The seal may be used by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced.

## ARTICLE VIII

### Financial Matters

SECTION 1. Accounting System and Reports. The Officers shall cause to be established and maintained, in accordance with generally accepted principles of accounting, an appropriate accounting system.

SECTION 2. Contract. Except as otherwise provided in these Bylaws, the Officers may authorize any Officer(s), agent, or agents, to enter into any contract or execute and deliver any instrument in the name and on behalf of the Corporation, and such authority may be general or confined to specific instances.

SECTION 3. Checks, Drafts, Etc. All checks, drafts, or other orders for payment of money, and all notes, bonds, or other evidences of indebtedness issued in the name of the

Corporation shall be signed by such officer(s), agent(s), employee(s), of the Corporation as shall from time to time be determined by designation of the Board.

SECTION 4. Disbursement of Funds. On all matters involving disbursement of funds, the Treasurer will be responsible for ascertaining any legal or tax consequences that might be incurred through such disbursements.

SECTION 5. Reserve Fund. There may be set aside out of any funds of the Corporation such sum or sums as the Board from time to time, in their sole discretion, think proper as a reserve or reserves to meet contingencies, or for such other purpose as the Board shall think conducive to the interest of the Corporation, and the Board may modify or abolish any such reserve.

SECTION 6. Deposits. All funds of the Corporation shall be deposited from time to time to the credit of the Corporation in such bank or banks as the Officers may select.

SECTION 7. Fiscal Year. The fiscal year of the Corporation shall begin on January 1 and shall end on December 31 of each year.

## ARTICLE IX

### Dissolution

Dissolution of the Corporation shall be according to the procedures established in Chapter 82 of the Nevada Revised Statutes. Upon the dissolution of the Corporation, after payment of all debts and liabilities of the Corporation, any and all remaining assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

## **ARTICLE X**

### **Indemnification**

Every person who was or is a party or is threatened to be made a party to or is involved in any action, suit, or proceeding, whether civil, criminal, administrative, or investigative, by reason of the fact that he or she is or was a Trustee or Officer of the Corporation or is or was serving at the request of the Corporation, shall be indemnified and held harmless to the fullest extent legally permissible under and pursuant to any procedure specified in the general corporation laws of the State of Nevada, as amended from time to time, against all expenses, liabilities, and losses (including attorneys' fees, judgments, fines, and amounts paid or to be paid in settlement) reasonably incurred or suffered by him in connection therewith. Such right of indemnification shall not be exclusive of any other right which such Directors, officers or representatives may have or hereafter acquire and, without limiting the generality of such statement, they shall be entitled to their respective rights of indemnification under any Bylaw, or otherwise, as well as their rights under this Article; provided, such person shall have been acting within the scope of his authority and in a non-fraudulent manner.

The Board may cause the Corporation to purchase and maintain insurance on behalf of any person who is a Director or Officer of the Corporation for any liability asserted against such person and incurred in any such capacity or arising out of such status, whether or not the Corporation would have the power to indemnify such person.

## **ARTICLE XI**

### **Amendments**

The Board, by a two-thirds (2/3) vote or two-thirds (2/3) written consent of all the members of the Board may amend the Articles of Incorporation or these Bylaws.

The Corporation reserves the right to determine on an ad hoc basis (1) the situations and circumstances where Nevada Highway Patrol officers, their spouses or families or other law enforcement or members of the public may need assistance due to illness, death, or injury, and (2) the education and training made available to help patrol officers, law enforcement personnel, or other persons be more effective in doing their jobs, and to promote and improve the safety of said officers and persons.

The Corporation intends to accomplish its goals and maintain its operations through the use of monies, equipment and property either contributed for its use or purchased on its own. In order to ensure the deductibility for income tax purposes of contributions made to it and the tax-exempt character of any income it may earn, the Corporation intends to retain its qualification as an I.R.C. Section 501(c)(3) tax-exempt organization,

contributions to which will be deductible under I.R.C. Section 170(b)(1)(A).

The Corporation may, but is not required to, set forth criteria as to who is entitled to receive assistance from the Corporation.
