The Remember Niger Coalition (RNC) is dedicated to uniting people and mobilizing resources to expand quality educational opportunities in Niger, West Africa. Since 2009, RNC has constructed or improved 43 classrooms in seven communities, serving over 2,200 children from pre-school through secondary school. In 2016, RNC began a partnership with the Hamsa Girls Education Center (HGEC) to address barriers to getting and keeping girls in school. RNC constructed a solar water well and security compound wall around the school in 2017 and the first classroom was completed in February 2018. Under local community leadership, HGEC will provide a safe space that will provide both formal and informal learning opportunities for adolescent girls and young women in Niger.

Malawi Children's Village's mission is to enhance the lives of orphans by providing educational, health, and social resources in 38 villages throughout Malawi. MCV has focused on improving the lives of Malawian children and providing access to education by establishing a school campus comprised of a primary school, secondary school, and housing for orphans. A central problem to abysmally low female education rates in Malawi comes from a lack of access to feminine hygiene products. When the girls at MCV's Secondary School begin menstruation, they do not have the ability to purchase pads or tampons and are often bullied or teased out of school by other students. This \$10,000 grant will help to start the Sanitary Pad Project with the goal of raising female attendance in the Secondary School (180 females currently enrolled) and subsequently raise exam scores.

Invisible Girl Project seeks to end the atrocity of gendercide in India. IGP has built a holistic model to address gendercide both on short-term and long-term,

systemic level. IGP's direct service work involves its RICE (Rescue-Intervention-Care-Endowment) Program, where social workers rescue girls vulnerable to female gendercide, intervene in difficult family situations to help daughters and mothers as needed, care for rescued girls and their mothers, and empower girls and women. IGP's social workers build relationships and engage with women and girls in 35 target villages with a reach of up to 30,000 people. This \$10,000 grant specifically provides assistance to place up to 250 vulnerable girls in their Education Assistance Program.

The \$6,760 grant to Razia's Ray of Hope Foundation provides textbooks, desks and chairs for teachers and students at the Zabuli Education Center in Afghanistan. The school provides free, exceptional education to more than 500 girls in kindergarten through grade 12 in Deh'Subz, Afghanistan.
