AIE - LA offers three certificate programs, including: 1. Advanced Diploma of Professional Game Development - Game Art & Animation (CIP Code 11 0803); 2. Advanced Diploma of Professional Game Development - Game Programming (CIP Code 11 0804); 3. Advanced Diploma of Screen and Media - 3D Animation & VFX for Film (CIP Code 10 0304).
