Sand Point Elementary funded an all school play that began with planning and learning in October 2017 and ended with the final performance in May 2018. The play was centered around the Native story of "Salmon Boy" and was led by the 4th and 5th grade students. The PTA brought in and collaborated with Native storytellers who taught the story to all the students and then the 4th and 5th graders developed a script and played the lead roles. The PTA also brought in choreographers and drummers to work with all of the classrooms so that every student had a part and performed in the play.

4b (Code:) (Expenses \$ 13,024 00 including grants of \$) (Revenue \$ 11,105 00)
Seattle Public Schools initiated an "early release day" during the school year for students and allowed teachers to have an extra 75 minutes of planning time every Wednesday. This resulted in a need for extra childcare so the Sand Point Elementary PTA helped to organize an afterschool enrichment classes for students. The PTA also provided full or partial scholarships for any and all families who needed or requested them.

The Sand Point Elementary PTA funded an art program at the school. Each classroom had art class for 1 hour per week for one half of the year (having music the other half of the year). The PTA funded the art instructor who taught students in compliance with Seattle Public School art curriculum and provided all supplies and volunteers.
