The exemptions are subject to periodic review by the federal and state taxing authorities and management is confident that Techbridge Girls continues to satisfy all federal and state statutes in order to qualify for continued tax exemption status. Techbridge Girls may periodically receive unrelated business income (such as sublease rental income) requiring Techbridge Girls to file separate tax returns under federal and state statutes. Under such conditions, Techbridge Girls calculates and accrues the applicable taxes.
