- 1) To support the operations and mission of the North Myrtle Beach Chamber of Commerce, Convention and Visitors Bureau, Inc., by serving as a vehicle to administer and underwrite civic, cultural, scientific, and educational programs through fund raising and grant-writing initiatives in order to help lessen the burden of local and state governments; 2) To support and administer community programs including cultural and educational awareness of promoting quality of life in the greater North Myrtle Beach, SC area; 3) To support and administer "Building North Myrtle Beach" and "Vision 2020" programs (public/private sector initiatives for economic and community development) as well as addressing workforce and educational issues confronting the community; and 4) To support and administer other community-based initiatives for the public benefit and enurement to the community as directed by the Board of Directors from time-to-time.
