Public Support, as set forth in Part II Section C Item 14 is only 18.2% of Total Support. However, this % is so low only because we have been very successful in attracting large givers. Over the past 5 years, we have seven givers that have given more than 2% of the total amount raised, totalling 81.2% of the total amount raised. All efforts of the organization are to raise funds for the benefit of Kishorit, a community for people of disabilities in Israel. Notwithstanding our large givers, we continue our efforts to raise funds from all potential supporters, large and small. These 7 large donors have no control of or representation on our Board.
