The Refindery re-use store: Usable items donated by the public and/or diverted from the trash are sold to support our recycling and community outreach programs. Items sold include household goods, small appliances, electronics, furniture, building materials, tools and fixtures

Customers include medium and low income individuals, artists, bargain hunters and 'do-it-yourself' craftsmen and seasonal visitors.

We encourage reuse as the preferred method of disposal through creative displays, events and promotions. We rent durable dinnerware, linens and utensils to the public to reduce the disposable items used at community events.

4b (Code:) (Expenses \$ 151,864 including grants of \$) (Revenue \$ 149,300)

Recycling Depot: Households and businesses drop off paper, plastics, metals, glass, paint, electronics, yard debris and other recyclable materials, which are separated into 40+ categories to maximize value when marketing to brokers and other recycled material buyers.

In calendar year 2017, CARTM processed 1,338.5 tons of recyclable materials, which represents 54% of the solid waste passing through our facility.

We encourage recycling by intercepting and diverting recyclable materials from trash, and through ongoing engagement with the public

Transfer Station: CARTM manages the Manzanita Transfer Station for North Tillamook County under a franchise agreement.

Households and businesses self-haul solid waste (trash) to our facility. Customers are actively encouraged to separate recyclable and reusable items from trash at no charge, saving them money on disposal fees, reducing the amount sent to the landfill, and retaining the intrinsic value of already-created materials. CARTM staff also diverts materials from unsorted trash loads.

Tillamook County pays CARTM a fee to operate the transfer station, as well as incentive fees for collecting certain recyclable materials on behalf of the County. We offer expanded waste processing services to home builders and remodeling contractors, who generate significantly more waste than households.
