The UMB Foundation supports academic programs, clinical activities and research in the University of Maryland School of Medicine (UMSOM). Established in 1807, UMSOM is the first public and fifth oldest medical school in the U.S. and the first to institute a residency training program. In 2018, the UMSOM graduated a total of 333 students with medical, allied health, or graduate degrees. Of the graduating students, 138 received their medical degrees and joined the ranks of more than 14,000 living alumni. Medical students matched with residency programs at 69 different hospitals in 30 states.
