THE FOUNDATION DOES NOT HAVE PAID EMPLOYEES. INSTEAD, IT REIMBURSES CARDINAL HEALTH FOR SERVICES PROVIDED TO THE FOUNDATION. THOSE PROVIDING SERVICES TO THE FOUNDATION (INCLUDING THE DIRECTOR), ARE EMPLOYEES OF CARDINAL HEALTH. IT HAS BEEN DETERMINED THAT 77.4% OF THEIR TIME THROUGHOUT THE YEAR IS SPENT ON FOUNDATION ACTIVITIES. THEREFORE, CARDINAL HEALTH CHARGES THE FOUNDATION 77.4% OF THEIR PAID COMPENSATION AND BENEFITS ON AN ANNUAL BASIS. FOR THOSE EMPLOYEES OF CARDINAL HEALTH WHO PROVIDE SERVICES TO THE FOUNDATION, AND WHICH THE FOUNDATION REIMBURSES CARDINAL HEALTH FOR 77.4% OF THE COMPENSATION AND BENEFITS, THE FOLLOWING AMOUNTS WERE PAID: COMPENSATION AND BONUS (\$566,817)
