

In a study conducted by an independent group, the foundation established the following data and trend lines for Ohio University donors who eventually gave \$10,000: i) before making their \$10,000 gift, they first participated in 9 to 13 annual fund years, ii) they made a gift in 7 out of 10 fiscal years just prior to making their \$10,000 gift, iii) 61% of all donors who made a \$10,000 gift made a first gift of \$50 or less, iv) 38% of all donors who made a \$10,000 gift made a first gift of less than \$25.
